John Knox Village Foundation Estate Society

The Board of Trustees established the Estate Society in 1993 to honor individuals who have included John Knox Village or the Foundation in their estates. The most common way to do this is through a will or trust. Many people set aside a certain dollar amount. Others leave a percentage of their entire estate or assets that are left over after family needs are met. Some leave their IRAs, paid-up life insurance policies or other financial investments. Investment in a Charitable Gift Annuity with the John Knox Village Foundation, which guarantees a dependable stream of income for life, also qualifies individuals for membership in the Estate Society.

The Ambassadors of the John Knox Village Foundation

The Ambassadors Executive Committee is a group of volunteers who represent the John Knox Village Foundation to their fellow residents. Their role is to learn about Foundation projects so they can field questions about what it is and why the various projects are important to residents and the community as a whole. They also assist with events and activities that increase the Foundation's visibility and raise needed funds.

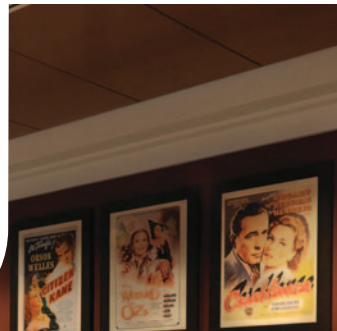
