### BioMed Central - new e-print service planned

BioMed Central (BMC), a new web initiative for biomedical researchers is to be launched in May 2000. It will give researchers the tools needed to publish data quickly and easily on the web. It will use web technologies to publish submitted research which has been carried out following accepted scientific criteria, to speed up the peer review process and to make all articles published through BMC available immediately and in full through the research archive, PubMed Central. PubMed Central is the proposed NIH repository for peer-reviewed primary research reports in the life sciences; it plans to begin accepting journal articles in January 2000. BMC will also participate in a parallel pre-print/e-print archive that will be closely integrated with the proposed PubMed Express e-print archive.

### BMJ biomedical pre-print site

### Access to Kluwer electronic journals via NESLI

From January 2000, Kluwer is offering a 2-year agreement to UK HEIs. The proposed agreement offers the option to purchase access to all the Kluwer Online titles for a percentage surcharge on print expenditure. In 2001, libraries will be able to cancel all of their print subscriptions in favour of electronic-only access, though with the option to buy print copies at favourable discount. The electronic journals can be access via the NESLI/Swetsnet interface, or direct via Kluwer online.

## News from SilverPlatter

SilverPlatter recently announced new features and enhancements that will shortly be available on SilverLinker. These include filtering by journal title, links to a broader selection of electronic providers, including ScienceDirect, and the availability of the service on the Internet and Partner Hosted Services. As well as this, SilverPlatter has recently acquired exclusive rights to the HMIC (Health Management Information consortium) database, which is available either on CD-ROM or via the Internet; the data will be updated every two weeks.

### Serials management module from Innovative

Innovative Interfaces completed beta testing of its new serials management module last autumn. The module, known as Millennium Serials, uses a Java-based interface that allows single-click access to the entire range of serials control functionality. A GUI screen gives users customisable windows functions, and user-friendly drop-down menus

and dialogue boxes. Other features include singleclick graphical issue-check-in, support for issuelevel URLs for electronic formats and a binding module.

## Enhancements to EBSCO's serials supply procedures

EBSCO Subscription Services and epixtech, inc. (formerly Ameritech) have recently launched EDI X12 format electronic serials claim facility for the Dynix ILS. Electronic claims are produced based on library-defined parameters, the systems builds an identifier that identifies the issue being claimed, and a new interface between the supplier's and library's systems allows the claim thus generated to sent to EBSCO via FTP. EBSCO has also recently upgraded EBSCONET so that customers can access and download their Monthly Claim Checker report.
