

# **DEOW's Japan Study Abroad Application Support Services Terms and Conditions**



Below are the Terms and Conditions that describe the relationship between DEOW Co. Ltd (hereafter, "We", "Us", and "Company") and the client (hereafter, "Applicant") who requests the Company to act on his or her behalf to carry out the application procedures to educational institutions, accommodation providers, and various support institutions in Japan (hereafter, "Institutions").

### JAPAN STUDY ABROAD APPLICATION SUPPORT SERVICES

### Nature of Services

We provide Japan Study Abroad Application Support Services (hereafter, "Services") to Applicants who are planning on applying through Us to a Japanese language, college or other program in Japan. We provide consultation, research support, correspondence with prospective schools, and support through the school application process. We also provide guidance and application support for accommodation. Pending program availability, Applicants who qualify may also join our Practical Japanese Communication Program.

Our Services do not apply to Applicant's participation in and successful completion of their studies in Japan, nor do we make any guarantees during or after the period of study in Japan at the educational institution to which he or she is or will be enrolled. We do not make guarantees regarding the Applicant's continued receiving of services from any Institution after initial registration has been completed

To apply, please fill in all of the required fields on our designated online application form, which will additionally entail agreeing to these Terms & Conditions.

We collect an Application Deposit (hereafter, "Deposit") from all Applicants requesting our Services in the amount of \(\frac{\pma}{30,000}\) JPY.

This Deposit is held by us and refunded back to the Applicant upon successful enrolment at the Institution in Japan. We collect this deposit solely as a guarantee that Applicants will fulfill their study abroad plans in Japan.

Applicants have the option to pay the Application Deposit by direct bank transfer, or via Paypal. Payments made by direct bank transfer will incur a transfer fee of ¥3,500 JPY. Payments made via Paypal will incur a transfer fee of 3.6%.

For Applicants who are joining the Practical Japanese Communication Program, the Deposit is required to be paid before the start of the first class.

This agreement will go into effect immediately upon receipt of a completed application form. Request to cancel his or her application should be submitted by the Applicant or his or her guardian in written form via email to DEOW Co. Ltd.

Agreement to these terms and conditions entails that the Applicant (or his or her guardian) has carefully read the contents herein, that all of the information provided to DEOW Co. Ltd is accura and true to the best of the Applicant's knowledge, and that the Applicant has acknowledged and agreed to these terms voluntarily.

- 1. These terms and conditions go into effect upon competition of the written application, which includes agreement of these terms and conditions.

  2. The Applicant may cancel his or her application at any time.

  3. In the event that, for reason out of the control of DEOW Co. Ltd, including but not limited to war, natural disaster, or an act of God, DEOW Co. Ltd is unable to provide its Japan Study Abroad Application Support Services, which includes the Practical Japanese Communication Program, these terms and conditions may be cancelled and DEOW Co. ## Termination
