TOWN OF CLEARFIELD ORDINANCE #9 Mandatory Source Separation of Solid Waste/Recyclables Section I Intent

It is the intent of the Clearfield Town Board of Supervisors that this ordinance be enacted for

these purposes.

1. To be in compliance with Juneau County Ordinance #90-1 Mandatory Source Separation of Solid Waste/Recyclables.

2. To help Juneau County extend the life of the Juneau County Landfill(s), and allow waste from the town admission into said landfills.

3. To help with the conservation of Natural Resources and to save energy by recycling, rather than disposing of designated recyclable materials.

Section II Definitions

For the purpose of this ordinance, the following terms shall be defined as shown and used in that context.

- 1. Designated recyclable materials-meansaluminum cans, corrugated cardboard ferrous metal cans, glass bottles and jars, high density polyethylene and polyethylene terphalate plastic containers, and newsprint.
  - 2. Solid Waste-any refuse/garbage not containing recyclable materials.

3. Landfill-County owned Juneau County Landfill Site(s).

Landfill User-any resident, business or governmental unit or other entity, which deposits or causes to be deposited, solid waste in the landfill.

5. Commercial Solid Waste Hauler-any person or commercial entity that deposits solid waste generated by a landfill user other than himself in the landfill, whether for pay or as a public service.

Section III Separation

of Waste

1. All landfill users from the Town of Clearfield shall separate designated recyclable materials from other solid waste before depositing that solid waste in the Juneau County Landfill, or arranging for pickup and delivery of such waste for deposit to said landfill. . .

2. All solid waste transported to the Juneau County Landfill shall be placed in clear plastic bage as designated in the Juneau County

Ordinance.

- 3. All recyclable materials shall be taken to a recycling center of the user's choice or deposited in the collection bins at the Landfill before depositing solid waste in the Landfill. User fees are the responsibility of the individual or business using the landfill services.
- 4. Owners of multifamily dwellings in the Town of Clearfield shall make available to their tenants separate bins for recyclable materials and solid waste. Individual owner policies shall determine who is responsible for disposal of solid waste and recyclable ma-
- Commercial, retail, industrial, and governmental facilities in the Town of Clearfield shall be responsible for the placement of containers at their facility for the separation of recyclables and solid waste. Proper disposal shall be the responsibility of the business or governmental en-

Section IV Violations

1. Commercial haulers hired by private individuals or businesses shall be liable under this ordinance for materials collected in the municipality and deposited in the Juneau County Landfill(s) by their vehicle(s). If the identity of the individual(s) that deposited recyclable materials together with solid waste can be determined, then the liability shall rest upon the violating individual(s). Determination of individual liability shall be the responsibility of the commercial hauler.

2. Individual users of the landfill are responsible for separation of recyclables form solid waste before depositing it in the

landfill.

Section V Enforcement

1. Enforcement of this recycling ordinance shall be the responsibility of Juneau County. When violations have been observed at the Landfill, warnings and citations shall be issued by the Juneau County Sheriff's Department to individuals or commercial haulers, based upon complaints from landfill personnel.

2. The Town Board of Supervisors concurs with Juneau County's right tofine users not less than \$25 nor more than \$100 for each violation and the right to deny entry into the landfill to any landfill user that violates the provisions of this ordinance by depositing recyclable materials in the landfill.

## AMENDMENT TO TOWN OF CLEARFIELD ORDINANCE #9 RECYCLING

Section 1.10 (8) is hereby amended to read as follows:

"MAJOR APPLIANCES" means a residential or commercial air conditioner, clothes dryer, clothes washer, dishwasher, freezer, oven, microwave oven-with capacitor removed, refrigerator, stove, residential or commercial furnace, boilers, dehumidifers, and water heaters. Note: Microwave ovens may be landfilled after capacitors are moved if there is no recycling center that will accept them.

## AMENDMENT TO ORDINANCE #9 ----- RECYCLING

The town board of the Town of Clearfield does ordain as follows:

Ordinance #9—Recycling ordinance is hereby amended to address the formation of one responsible unit for the purpose of recycling in Juneau County of which the Town of Clearfield has become a member. This responsible unit, known as the County recycling Agency for municipalities (CRAM) has been created pursuant to Section 66.30 and 287.09 WI S.S. for the purpose of efficient and affective recycling. The Town of Clearfield has entered into an intergovernmental agreement with other municipalities and Juneau County, to establish a recycling drop off site at the Juneau County Landfill. Recyclable material is to be deposited in the proper collection bins and is to be clean and sorted.

Recyclables may be brought to the landfill at the same time garbage is brought to the landfill. Landfill fees will apply for garbage but there will be no additional charge to the residents of the Town of Clearfield to recyclable items deposited in the recycling area.

Occupants of single family and two to four unit residences, multiple family dwellings and nonresidential facilities and properties shall separate the following materials form post consumer waste and deposit the clean recyclable materials in the proper containers provided at the Juneau County Landfill site, as Bickford Recycling is no longer a recycling drop off site for the town of Clearfield:

Aluminum cans, container glass-all colors, corrugated cardboard, mixed papers, newspapers, plastic bottles, and tin cans are acceptable. The landfill will also accept tires, waste oil, lead acid batteries, appliances and scrap metals, but a fee may be charged for these items.

Yard waste, and leaves will not be accepted at the landfill site and must be disposed of as previously outlined in Ordinance #9.

It is not intended by this amendment to the existing ordinance to repeal, abrogate, annul, impair or interfere with any existing rules, regulations, ordinances, or permits previously adopted or issued pursuant to law.
