March 2025 Key Highlights

Town of Caledonia property taxes amongst the lowest in Waupaca County!

After the recent revaluation in 2024 and resulting property tax bills were sent, the Waupaca County Treasurer published the tax rates for all twenty two townships in Waupaca County. The Town of Caledonia property taxes are the third lowest of all twenty two townships in the County! Only the Towns of Dayton and Farmington had slightly lower tax rates. This was accomplished while making significant improvements to town roads, recreational opportunities and park improvements, and the town hall facilities. The Town Board has a strategy to make improvements to the town without increasing property taxes by seeking grants, donations, and applying for various State and Federal aids. The Town Board strives to improve our township while keeping taxes as low as possible.

More exciting broadband expansion news for Caledonia!

As we have announced in the past year, Spectrum has installed high speed broadband fiber optic internet service in about one third of our township. This project should be completed in May of 2025, and many residents have already been hooked up. In February, Brightspeed approached the Town asking for our support to apply for a grant to install high speed fiber optic cable for those residents who are located in the Brightspeed service area. This will impact 282 residences in the southeast portion of the town and includes all three subdivisions and the area around Readfield. If we are successful in receiving this grant and adding it to the nearly completed Spectrum project, nearly all Town of Caledonia residents will have high speed fiber optic internet service available! Brightspeed will offer speeds of 200 to 2000 mbps at a cost of \$39 to \$99 per month. The Town Board has worked hard over the past decade to get high speed internet service to every resident in the township and finally these efforts are paying off. (See page 3 for details)

Gruetzmacher Park development has begun!

A Town Board team has begun the process of creating the final design and engineering for Gruetz-macher Park. These plans will be presented to the DNR the first week of April, 2025, to obtain the final approvals before starting construction in May this year. This park will be an incredible asset for the residents of Caledonia and will be constructed with grant funding and donations and not tax dollars! A grant of \$433,000 was received from the Knowles Stewardship Fund and the Ivan and Jeanette Gruetzmacher Family donated the land, a huge financial donation to build the park, and are creating a fund to pay for maintenance and future improvements forever. 
CURRENT BROADBAND EXPANSION PLAN


The Town of Caledonia Town Board has focused on expanding fiber optic broadband service to every residence and business in the township and this remains a top priority for 2025. In 2024, Spectrum began expansion of broadband service in about one third of the township and plans to begin hooking up residences by April of 2025. This was a great start but much more needs to be done to provide this service to every residence in the township. We had worked hard to get Spectrum to expand throughout the rest of the town and they had expressed interest in doing so. <u>Unfortunately, recently they notified the Waupaca County Broadband Expansion Committee that they now do not plan to expand further in the County at this time.</u> This was a great disappointment and has caused us to once again change plans to get this work done.

Recently, <u>Brightspeed approached the Town and asked for our support to expand fiber optic cable service in their service area in Caledonia</u> and the Town of Fremont. They plan to apply for a federal grant in February, 2025, and the work would be started in late 2025 but more likely early 2026, if the grant is approved. This development is very encouraging and the Town does plan to support Brightspeed in any way possible. Waupaca County plans to support them as well. **When the expansion area for Brightspeed is overlaid with the Spectrum coverage area, the entire Town of Caledonia will be covered with high speed fiber optic cable**. (see map below). Brightspeed plans to offer speeds of 200 to 2000 mbps at a cost of \$39 to \$99 per month. This is a huge opportunity and the Town Board will do everything possible to make it happen.

ANR PIPELINE CONSTRUCTION: Minimizing Impact & Protecting Roads

ANR Pipeline construction will begin as soon as spring weight limits are lifted. This massive project will have significant impacts on our town, but the Town of Caledonia Town Board has been working closely with ANR since 2022 to ensure everything goes as smoothly as possible.

The project involves hundreds of trucks per day carrying oversized pipeline materials through our town. The roads most impacted are: US 96, Cty Hwy W, Cty Hwy HH, Brehmer, Ernst, Weiland, and Rawhide. Additionally, ANR Pipeline will be drilling under the river for an anticipated 37 days.

Though the Town Board has no direct control over pipeline projects, the board has been negotiating with ANR since 2022 with a primary focus on safeguarding our town's most valuable asset - our roads - and minimizing disruption as much as possible. The Town of Caledonia successfully negotiated with ANR to select specific haul routes, helping to protect our local infrastructure. Additionally, the board secured a commitment from ANR to compensate the town for any damage caused during the construction process.

To ensure our roads are restored as quickly as possible, road crews are already lined up to start repairs immediately after the pipeline work is completed in the Town. County Hwy W will also undergo road work following the completion of the project.

The Town Board's proactive leadership and collaboration with ANR are helping to protect our community, reduce disruptions, and maintain our infrastructure. If you have any concerns, please contact Supervisor Bosquez.

PROPOSED PAVILION — GRUETZMACHER PARK



GRUETZMACHER PARK CONSTRUCTION BEGINS SOON!

Excitement is building as final preparations are underway for the construction of Gruetzmacher Park in the Town of Caledonia. This 47-acre park will be situated on land generously donated by the Ivan and Jeanette Gruetzmacher Family, located along Bean City Road. Construction is slated to begin in late May 2025, with the initial phase of the project expected to be completed by the end of 2026.


The park will focus on "silent sports," such as walking, biking, playground activities, and other low-noise pursuits. In addition to recreational space, it will feature nature-based and environmental education opportunities. To ensure the project moves forward smoothly, the Town Board has formed a committee to finalize the designs, layouts, and engineering plans. These plans will be submitted to the Department of Natural Resources (DNR) for final approval in the first week of April.

The development of Gruetzmacher Park is a tremendous opportunity for the Town of Caledonia, as few townships boast facilities of this caliber. What makes this project truly remarkable is that Gruetzmacher Park will be built without any cost to local taxpayers. All funding for the park will come from grants and donations. The State of Wisconsin's Knowles Stewardship Fund has provided a grant of \$433,000 to help bring the park to life. Additionally, the Ivan and Jeanette Gruetzmacher Family has not only donated the land but is also establishing a multi-million-dollar trust fund to provide between \$50,000 and \$100,000 annually for park maintenance and future improvements.

Thanks to these generous contributions, there will be no cost to Town residents for the land, the development of the park, or its ongoing upkeep. This project has truly exceeded all expectations!

We've included a few pictures showcasing some of the **proposed** park components to give you a glimpse of what's in store! These are conceptual plans and the plans will continue to evolve through the planning process. The proposed site plan below is the long-range plan for the park. Not all of the components will be completed in the next two years.

NEW YARD WASTE OPPORTUNITY



Town of Caledonia residents now have access to the City of New London's yard waste debris site behind the Wastewater Treatment Plant off of Werner-Allen Road.

In order to access the yard waste debris site, you must purchase a key card and annual waste sticker from the City of New London Public Works Department. There is a one time payment of \$5 for the access card and then \$5 for the annual sticker. The key card and sticker can be purchased at the Municipal Service Building Public Works Department entrance (west side of the building). You will need to show proof of residency and provide the license plate number of the vehicle you'll use to haul the yard waste.

We're excited to partner with the City of New London to provide a yard waste solution!

BURNING PERMIT PROCESS

When you're planning to have a burn please follow these 2 steps:

- 1. Check with the DNR to see if you can burn (https://dnr.wisconsin.gov/topic/forestfire/permits)
- 2. Call or text Fire Chief Degal at (920) 213-5324 when you start a fire and when it's done

DOG LICENSES & ANIMAL CONTROL UPDATE

Pet Owners, let's talk about your responsibility to keep your pets safe and secure on your home and property. Wisconsin State law in (Chapter 174) states that in the case of dogs, they must be vaccinated for RABIES after 5 months old and to be kept current on that vaccine. It also states you as a dog owner need to license your

dog and keep it current by renewing you dog license every year before March 31st. You might say, well my dog is an inside dog and only goes outside to do his or her thing. Well, that is when most dogs take off. Be it a hole in a fence, chasing deer or what have you, they are gone. I, as your Town Supervisor/Animal Control Officer, have two live traps that we can lend to you. There is a \$35 deposit on their use and then if returned to us undamaged you will get that deposit back. We also purchased a microchip reader that can identify the owner of a dog or cat that has a microchip implanted in them. I have been doing this job for close to twenty years and dogs and cats getting away from their owners is increasing to several times a month.

Let me walk you through a typical scenario. I get a call, most of the time it is in the evening and the animal has been gone for many hours or some homeowner has a dog or cat in their garage that is a stray. In that case I would try to identify the animal, be it having a license, a RABIES tag or even a tag with owners' information on it or a microchip. If I can't determine the owner, then I take it to the Waupaca Humane Society and have it impounded there. If some how you find your dog is there (on their Facebook site), it's going to cost you our pickup fee of \$50, the Human Society's impound fees and any daily boarding fees and if you can't prove your animal (dogs or cat) is vaccinated for RA-BIES, you will pay that also before you get your animal back. If it is determined that your dog isn't licensed, you will incur a late fee from us.

Waupaca Humane Society (715-258-2545) offers a monthly microchip clinic, and the cost is \$25 and that includes registering it with one of the national registries. Your veterinarian could do this also. You could also put your phone number on the back of the animal's license, rabies tag or other tag. If I can identify your animal I will bring it back to you, you still will owe the Town the \$50 pick up fee, but that is a lot cheaper, if dog isn't current on their license you will have to take care of that also.

One last thing, you can't get a license for your dog without prove of up-to-date RABIES vaccine. It is inevitable that your dog or cat gets out and is bitten or scratched by a wild animal that has rabies. Look it up, I think of only one person that has survived late stages of RABIES, and she was from southwestern Wisconsin. I believe she was playing with a bat. In closing, there are 900 residential homes in the Town and yet we only get owners to license about 140 dogs each year and many have multiple dogs. LOVE YOUR DOGS AND CATS, GET THEM VACCINATED AND HAVE THEM HAVE SOME FORM OF IDENIFICATION ATTACHED TO THEM. BE RESPONSIBLE.

Dog License Information:


Complete the Caledonia Dog License Application on the website or available in the mailbox outside the Caledonia Community Center and submit completed application, current rabies vaccination certificate, and appropriate fee along with a self addressed stamped envelope to the town treasurer at PO Box 190, Readfield WI 54969 or put it in the drop box on the front door of the community center building. Dog license applications are due by March 31 annually.

Fee: \$5 for spayed/neutered dogs or \$10 for non-spayed/neutered dogs. A current rabies vaccination certificate must also be submitted.

Kennel licenses (\$60) are needed if you have 4 or more dogs.



2025 TOWN BOARD PRIORITIES

The Town of Caledonia Town Board works hard to ensure the community thrives! In 2025, the Board is focused on delivering key projects that will have a lasting impact on the quality of life for residents. Here's a look at some of the priority initiatives the board is focusing on this year:

- ANR Pipeline Project & Road Repair. The ANR Pipeline project will begin soon, bringing significant truck traffic through our town. While this may cause temporary disruptions, the board has worked diligently to minimize the impact. Once the pipeline work is completed, road repairs will begin immediately to address any damage caused. For additional details, see page 4.
- Gruetzmacher Park Development: A New Community Hub: Exciting things are happening at Gruetzmacher Park on Bean City Rd! Thanks to the generosity of donors and successful grant efforts, development of this 47-acre park is officially underway! Once completed, the park will be a hub for outdoor recreation in our community featuring an expansive trail system, playground, pickleball courts, a pavilion, and even a sledding hill.
