Background Information:

The Town of Caledonia is a rural community located in the southeast corner of Waupaca County. Readfield Park is located at E9181 State Rd 96, Readfield WI 54969.

Scope of Work:

- 1. Contractor shall mow the grass when it reaches four inches in height within the area in the attached map (the "Zone"), incorporated by reference herein.
- Contractor shall trim all grass around all structures, roadways, parking lots, and sidewalks within the Zone.
- 3. Contractor shall collect and dispose of fallen leaves in the Zone.
- Contractor shall move all picnic tables, benches, garbage cans, and other similar objects as necessary
 to finish mowing the Zone. Contractor shall return all objects to their initial spot after mowing is
 completed.
- Contractor shall maintain both baseball diamonds that are fully or partially within the Zone.
 Maintenance includes but is not limited to removing water, adding sand as needed, and dragging the infield of the two diamonds before Medina Dale Readfield Baseball Club (MDR) games.
- 6. Contractor will manage and remove weeds and unwanted grass in the entire park and on the infield of the baseball diamonds.
- 7. Placing bases and marking the infield are not included in this Contract.
- 8. Contractor shall provide all equipment necessary to fulfill Contractor's duties under this Contract.
- 9. No snow removal is included in the Contract.

General Quotation Requirements:

All quotations must identify the firm name, address, and experience in Wisconsin. The proposals shall
also include the name(s) and contact information of the person(s) to be assigned as the Town's point of
contact for the work to be performed.

- 2. The proposal shall include the total compensation rate to provide the lawn services described in the above Scope of Work.
- 3. The proposal shall identify 3 references from clients for which the bidder has provided lawn care services. References must include the name, title, address, phone number, and email of the reference contact.
- 4. Bidders are advised to carefully inspect the facilities of the Town of Caledonia and examine the above referenced properties for the proposed work and judge for themselves the circumstances affecting the cost of the work or the time requirements for its completion.
- 5. The successful bidder is not permitted to assign, subcontract, or transfer the work of providing lawn care services, without the prior written approval of the Town.
- 6. The successful bidder shall maintain full insurance coverage to protect and save harmless the Town from claims, demands, action and causes of action in execution of work.
- 7. The successful bidder will maintain Workmen's Compensation and Public Liability Insurance on all employees.
- The proposal must include a draft contract or statement of proposed terms, including provisions for contract termination.

Evaluation criteria:

The proposals will be reviewed and awarded to the lawn care provider whose quote is the most responsive to the solicitation and is the most advantageous to the Town of Caledonia, considering experience, price, and other factors. The Town reserves the right to accept or reject all proposals received.

The following criteria will be used to review the Lawn Care Services Proposals:

- 1. Demonstrate successful experience and quality of service.
- 2. Evidence of positive customer interaction & responsiveness to the municipal staff.
- 3. Cost of lawn care services.

Term of Engagement:

The lawn care provider will be selected directly by the Town Board. The Town will propose a 1 year service contract with the lawn care provider selected. The following is a list of key dates:
