DESIGNATION OF LOCATION OF STOP SIGNS

The Town Board of Leola, Adams County, Wisconsin do ordain as follows:

In accordance with Section 349.07(8) of the Wisconsin Statutes, and in the interest of public safety, the Leola Town Board hereby designates the following locations for the installation of stop signs to control traffic on the roads over which the Town of Leola has exclusive jurisdiction:
