Once your application has been approved, your license will be available through your employer.

□ PLEASE be advised that the Police Department will review and verify the information on your application. If any information is omitted, incomplete, or incorrect it is likely that the police department will reject your license application.

Pay the license fee

□ A background check will be conducted by the Police Department. Upon approval, new applicants will receive a temporary license in **7-10 business days**.

□ To receive the permanent license, please provide proof of successfully completing a training course that is approved by the Wisconsin Department of Revenue (must be completed within the last two years), or proof that you have been a licensed bartender in the state of Wisconsin within the last two years. This proof may be submitted at the time of application, otherwise must be provided within 60 days of the application date.

□ Classes are provided online at www.revenue.wi.gov select a training course under the title "Alcohol Seller/Server".

□ Renewal applications should be submitted 30-60 days prior to the expiration date to allow for processing time and Village Board approval.
