This packet contains specific information for the lottery for one affordable homeownership unit at Evergreen Village, a six-unit townhouse condominium development in Medway, MA, 02053 including eligibility requirements, the selection process, and a lottery application.

Project description

The **Evergreen Village** Townhouse Condominium development is permitted by the Town of Medway Planning and Economic Development Board. As required and permitted, one (1) of the six residences is being offered for sale to low and moderate income households under a Multi Family Overlay District Special Permit.

The **Evergreen Village** development consists of 6 townhouse/condominium units, with 1 designated as affordable. The development is located on 1.44 acre site located at 22 Evergreen Street. The development will include construction of two 3-unit, townhouse style buildings. Access to the development will be from a new 150' long permanent private roadway to be known as Balsam Way off of Evergreen Street.

The development consists of two buildings each contain three (3) units. There are two and three bedroom units. The affordable unit is two bedrooms.

The unit is available for immediate occupancy. Note that the unit and schedule may change without notice as market conditions change.

In accordance with the program guidelines, the initial purchase prices are established so that a household is not required to spend more than 30% of 70% Boston Area Median Income (AMI) monthly for housing costs.

The affordable unit is the plan numbered 6 Balsam Way, Medway, MA 02053. The floor plan is available on the Lottery Agent website @www.norfolk.ma.us.

The unit is 1706 square feet with 2 Bedrooms, 2 full baths, one ½ bath and a two (2) car garage. The first floor is an open floor plan with kitchen and open dining and living room and a half bath. The second floor has a master bedroom/bathroom and a second bedroom and full bathroom.

The kitchen comes with stove/oven, dishwasher All units will be provided with heating and central air-conditioning and are on Town water and sewer.

In addition to mortgage principal, interest and Private Mortgage Insurance payments, homeowners should expect to pay monthly housing expenses of property taxes and a condominium association fee of \$220.00 (HOA) per month. Property owners will be expected to pay property taxes of \$4,714.20 per year or \$392.85 month. The tax rate is determined by using Medway's 2022 tax rates, or approximately \$17.46 per 1,000/thousand.

Lottery description:

- The applications for this housing opportunity will be generally available, including on-line, in hardcopy at Medway
 Public Library, Medway & Norfolk Town Halls (business hours), and Medway Housing Authority (business hours), and
 will be sent or emailed to anyone interested in the lottery. Notice of the lottery will be advertised, and communicated
 widely through local, regional and state channels. For online applications go to <u>www.norfolk.ma.us</u> or email

- Applications must be received in hardcopy and will be checked for completion of all required components. An
 application will be considered complete when all required items on the checklist have been provided. Applicants are
 encouraged to complete the checklist as an aide to the process. We do not accept email or fax submission of
 applications.
- 3. For this unit, the applicant's household size will be determined from the application, and required number of bedrooms as indicated on the application. Within each lottery pool, priority shall be given to households requiring at least the number of bedrooms for that unit. Smaller households are encouraged to apply.
 - There is at least one occupant and no more than two occupants per bedroom.
 - A husband and wife, or those in a similar living arrangement, shall be required to share a bedroom.
 - School-aged children of the opposite sex are not expected to share a bedroom.
 - Other household members may share but shall not be required to share a bedroom.
- 4. The applicant's income will be verified and compared to the income limits published by HUD for the Boston Metropolitan Statistical Area. Income includes all income prior to any deductions from all adult household members, . The current 2022 income limits are:

- 5. Household assets shall not exceed \$75,000 in value. Assets include but are not limited to all cash, cash in savings accounts, checking accounts, certificates of deposit, bonds, stocks, the cash value of retirement accounts, value of real estate holdings and other capital investments. The value of necessary personal property (furniture, vehicles) is excluded from asset values.
- 6. Eligible applicants must be a First-time Homebuyer. This is further defined as a household that has not owned a home within three years preceding the application including in trust, with the exception of displaced homemaker, single

parents and senior households (at least one household member is 55 or over). Any previously or currently owned home must be sold prior to purchase of the affordable unit.

- A displaced homemaker is an individual who is an adult, who has owned a home only with a spouse, who is legally separated from a spouse, and who does not currently own the home previously owned with a spouse.
- Single parents are individuals who owned a home with his or her partner or resided in a home owned by the partner and is a single parent (is unmarried or legally separated from a spouse and either has 1 or more children of whom the individual has custody or joint custody, or is pregnant);
- Additional exceptions are made for households that owned a principal residence not permanently affixed to a
 permanent foundation, and households that owned a property that was not in compliance with State, local or
 model building codes.
- Eligible applicants cannot own residential property, whether for primary, secondary or investment purposes.
- 7. Persons must submit all the necessary information by the application deadline. Late applications (applications mailed and/or received after the above date) and applications that are incomplete will not be accepted. No faxed or emailed applications will be accepted.
- 8. All applicants will be screened for eligibility. Applicants who have been deemed ineligible will be notified in writing of the decision and given time to contact the Lottery Agent in writing to disagree with the determination.
- 9. Once the Lottery Agent has verified the information contained in the application and confirmed eligibility, a lottery number or numbers and lottery form will be issued, and the applicant will move forward to the lottery. There will be one lottery pool created for this opportunity.
 - 1) General Pool (1 units):
 - 2) A final lottery eligibility letter will be mailed to each applicant indicating their final eligibility determination, preferences and the lottery specifics (date/time).
- 10. The lottery numbers will be pulled randomly by an independent third party in a public setting. Lottery numbers will be assigned a number in the sequence in which they are drawn and recorded in the order of selection on the Lottery Drawing Lists. The list of numbers drawn will be posted and letters will be mailed within three business days to the winners.
- 11. Once the tickets have been randomly drawn and listed in the drawn order, the units are then ranked based on bedroom size. The top ranked household needing at least two bedrooms will be offered the opportunity to purchase that specific unit. The household size preference shall be given to households based on the following criteria.
 - There is at least one occupant and no more than two occupants per bedroom.
 - A husband and wife, or those in a similar living arrangement, shall be required to share a bedroom.
 - Other household members may share but shall not be required to share a bedroom.

" "Occupancy standards will not be more restrictive than the State Sanitary Code".

- 12. The Lottery Agent shall maintain all Lottery Drawing Lists. In the event that any of the applicants withdraw for any reason, or do not comply with guidelines, the next qualified applicant in the lottery pool ranked by bedroom size need, will be offered that particular unit.
- 13. Top ranked applicant is offered the unit.
- 14. The winner will sign a reservation form with the developer.
- 15. Final qualification against all requirements will be verified before the execution of Purchase and Sale, and the eligible applicant must be approved by the Monitoring Agent (DHCD) before signing a P&S and again before closing (if closing is longer than 60 days from the Purchase and Sale) as determined by the Lottery Agent.

- 16. There are specific closing and financing requirements for loans on these units, which include:
 - The loan must have a fixed interest rate through the full term of the mortgage.
 - The loan must have a current fair market interest rate.
 - The interest rate must be locked in not floating.
 - The buyer must provide a down payment of at least 3% (\$8100), 1.5% (\$4050) of which must come from the buyer's own funds.
 - The loan can have no more than 2 points.
 - The buyer may not pay more than 38% of their monthly income for monthly housing costs.
 - Loans from non-institutional lenders will not be accepted.
 - Buyers are encouraged to go to lenders that have familiarity with the Deed Restricted properties such as Lenders working with MassHousing and Mass Housing Partnership.
- 17. Closing documents will include disclosure statements from the Monitoring Agent. Additionally, the applicant will need to provide documentation that they have completed a certified first-time home buyer class. Home Buyer Education: It is suggested by the Town of Medway that you complete a pre-purchase homebuyer education course at a Massachusetts Homeownership Collaborative certified agency before closing. A list of courses, which is updated periodically, is on the MHP website (www.mhp.net). And CHAPA (www.CHAPA.net).
- 18. The Fair Housing Act prohibits discrimination on the basis of race, creed, color, sex, age, disability, marital status, familial status, veteran status, sexual orientation, and/or national origin, or any other basis prohibited by law and is specifically prohibited in the sale of these units. An applicant who believes that they have been discriminated against in the buyer selection and sales process may contact: the Massachusetts Commission against Discrimination; and/or the United States Department of Housing and Urban Development.
- 19. Disabled persons are entitled to request reasonable accommodation of rules, policies, or services, or reasonable modification of housing.
- 20. Resale process: The Monitoring Agent has up to 90 days after you give notice of your intention to sell the home to close on a sale to an Eligible Purchaser, or to close on a sale to a Monitoring Agent, or to a buyer that one of them may designate. This time period can be extended, as provided in the Deed Rider, to arrange for details of closing, to locate a subsequent purchaser if the first selected purchaser is unable to obtain financing, or for lack of cooperation on your part. If you attempt to sell or transfer the home without complying with the Deed Rider requirements, the Monitoring Agents may, among their other rights, void any contract for such sale or the sale itself.

- The property must be the owner's principal residence.
- The property can't be refinanced without prior approval of the Monitoring Agent (Town of Medway & Department of Housing and Community Development). Affordable units may not be refinanced for more than 97% of their Maximum Resale Price.
- There is a limit on the resale price of the unit so that the unit will always be affordable. The formula for calculating the maximum resale price will be established at the time of purchase and will be based on the Area Median Income at the time of resale. If an owner wants to sell their affordable unit, they are required to notify the Monitoring Agent.
- No capital improvements can be made without the Monitoring Agent's pre-approval.

I/We have been advised that a copy of the Mass Housing Universal Affordable Housing Deed Rider is available with the Lottery Agent.

I/We understand that if I/we are selected to purchase a home, I/we must continue to meet all eligibility requirements of the Monitoring Agent and any participating lender(s) until the completion of such purchase. I/We understand that I/we must be qualified and eligible under any and all applicable laws, regulations, guidelines, and any other rules and requirements.
