2020 OPEN BURN PERMIT

Massachusetts Law Governing Open Burning

Open Burning is allowed from January 15th to May 1st between the hours of 10:00a.m. to 4:00p.m.

ALL FIRES MUST BE EXTINGUISHED AT 4:00PM

1. Call the Medway Fire Dept. on the day that you wish to burn at **508-533-3209** and provide your permit #, name & address (no daily permits issued after 2:00p.m.)
2. Burning of STUMPS, LEAVES, FIELDS, RUBBISH OR BUILDING MATERIALS IS NOT PERMITTED. THE USE OF GASOLINE IS PROHIBITED.
3. Burning must be at least 75 feet from any building.
4. A garden house, rake, shovel or pressurized water extinguisher must be available for control of the fire.
5. Keep brush piles to a small, manageable size.
6. Someone must attend and control the fire until it is completely extinguished.

ANY VIOLATIONS OF THE ABOVE REGULATIONS COULD RESULT IN YOUR BURNING PERMIT BEING REVOKED FOR THE REMAINDER OF THE OPEN BURNING SEASON.
