Thank you for submitting a Sign Design Review application for Dior Barbershop to the Medway Design Review Committee (DRC) for review. The application and associated materials were filed with the Town by permitting consultant Claudia Sierra, on Tuesday, December 19, 2025.

Pursuant to the Medway Zoning Bylaw, this communication serves as the DRC's review letter regarding the proposed freestanding sign design for 79 Main Street. Please be advised that this letter does NOT constitute approval of a permit by the Town of Medway.

On Monday, January 5, 2026, the DRC met with Claudia Sierra to review the proposed freestanding monument sign for 79 Main Street.

You have proposed the following as represented on the sign designs submitted:

- QTY 1 Free-standing Monument sign – 6'x 4' double-sided (48 sq. ft.)

The DRC has the following recommendations:

- Dior Sign must remove the phone number to comply. Once that update has been made, the DRC approves the sign design.

You are welcome to return to a future DRC meeting for further conversation and ideas regarding signage for 79 Main Street. Please contact the Medway Planning and Economic Development office at 508-533-3291 if you would like to schedule another appointment with the DRC.
