**MEDWAY ZONING BOARD OF APPEALS**

Notice is hereby given that the Town of Medway **Zoning Board of Appeals** will conduct a **Public Hearing** on **Wednesday, March 04, 2026** at **7:30 P.M.**, in **Sanford Hall** at the **Medway Town Hall, 155 Village Street, Medway, MA** on an application from **Paul Atwood**, with respect to property located at **116 B Winthrop Street**, Assessor Parcel No. 08-24, in the Agricultural Residential I (AR-I) Zoning District.

The application requests a variance from Section 7.2 Table 4 of the Zoning Bylaw to erect a free-standing entrance sign exceeding the maximum allowed height and within the minimum setback for signs.
