Thank you for submitting a Sign Design Review application for Isaac & Son’s Auto Repair to the Medway Design Review Committee (DRC) for review. The application and associated materials were filed with the Town by Funwayo Mafuleka of Flakers Carving on April 8th, 2026.

Pursuant to the Medway Zoning Bylaw, this communication serves as the DRC’s review letter regarding the proposed wall sign design for 136 Village Street. Please be advised that this letter does NOT constitute approval of a permit by the Town of Medway.

On Monday, April 13th, 2026, the DRC met with Funwayo Mafuleka to review the proposed wall sign for 136 Village Street.

You have proposed the following as represented on the sign designs submitted:

- QTY 1 Non-Illuminated Wall Sign – 9’ x 3’ (27 sq. ft.)

The sign will be mounted by pressure treated lumber and screwed on frame with washer head screws. The lumber frame will be bolted into the metal cladding with ten toggle bolts. The sign will be painted blue with a mix of white and orange lettering.

Brilliant Blue #P510, Sheen: Flat (background)
Ultra White Exterior, Sheen: Semi-gloss (Text)
Joyful-Orange #P240-7, Sheen: Semi-gloss (Text)

The DRC has the following recommendations:

- Ensure that signage band has been properly cleaned prior to install
