WHEREAS, Wisconsin statutes require that wards be established to permit the creation of supervisory districts of equal population,

THEREFORE, BE IT RESOLVED, that the following ward is hereby created for the Town of Sterling.

Ward 1: North: 300th Avenue South: County Road G
 East: 240th Street West: 340th Street

BE IT FURTHER RESOLVED, that the above ward boundaries are outlined and identified on the attached map, which is incorporated and made a part hereof, and containing the census block numbers within each ward and

BE IT FURTHER RESOLVED, that for all voting purposes, the above wards will be combined using one common polling place, as required by law.

The designated polling place will be: Cushing Community Center, 2510 241st St., Cushing, WI 54006.

The town clerk shall properly post this resolution as required under s. 60.80, Wis. Stats.

Adopted this 7th, day of October, 2021.



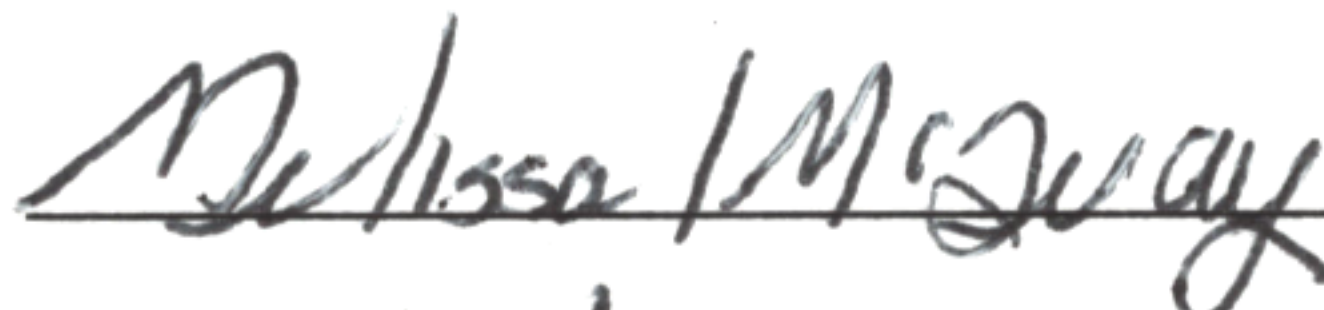

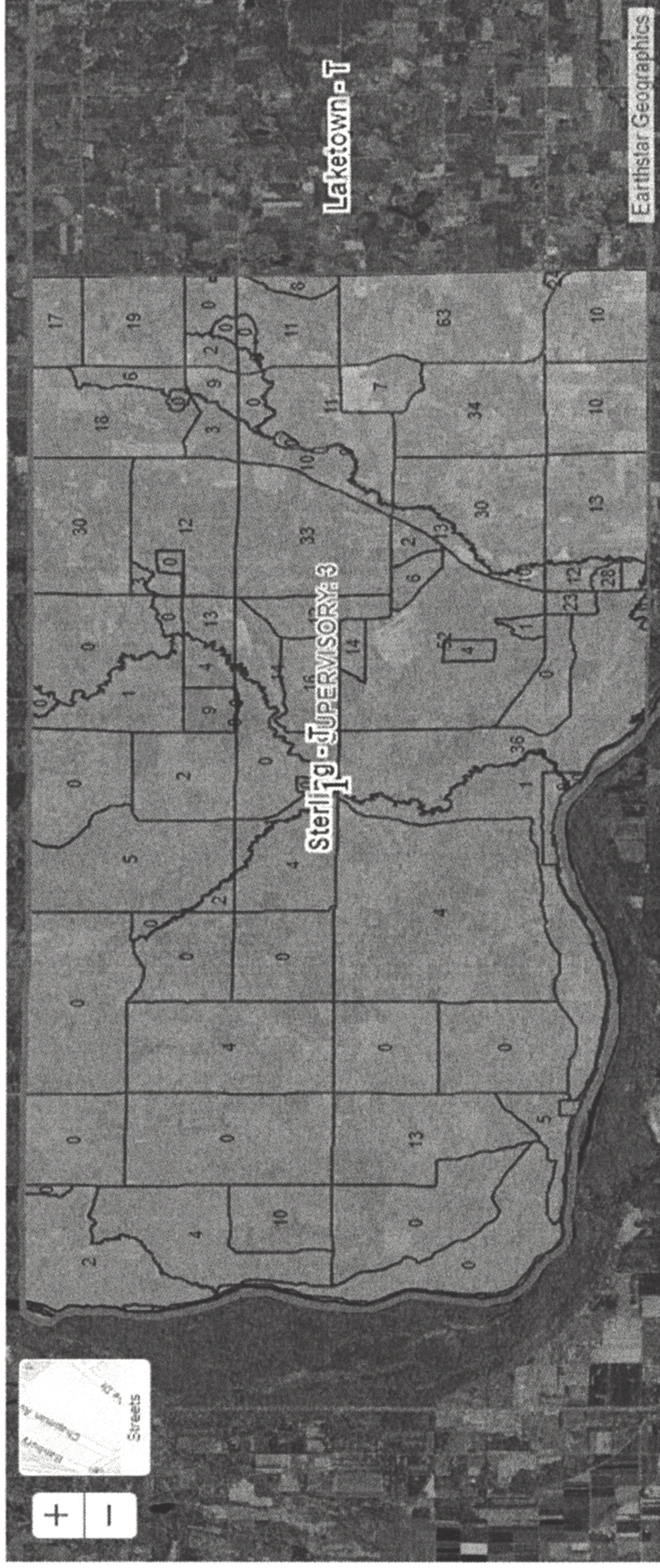

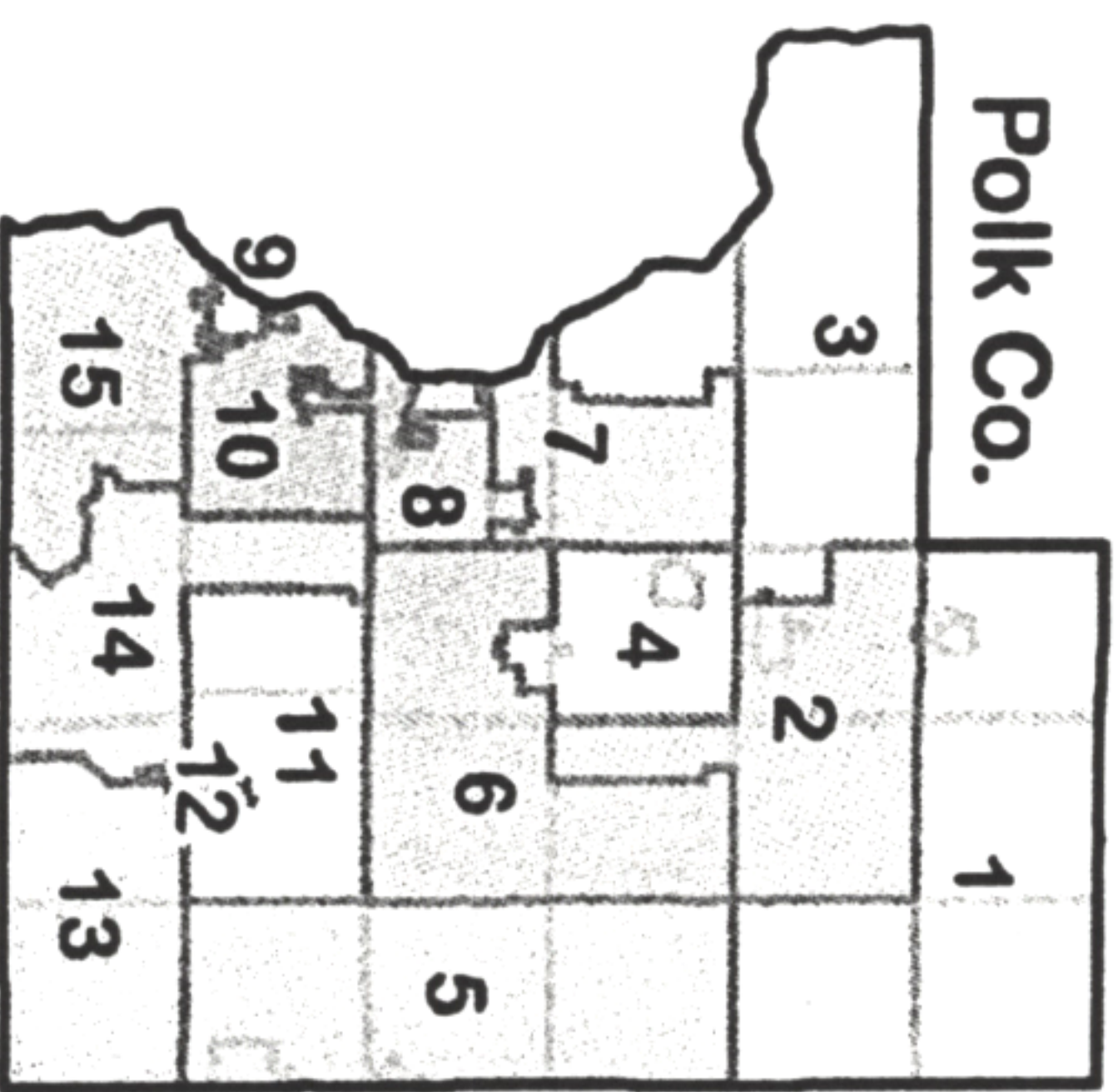
