AN ORDINANCE AMENDING THE 2019 BUDGET OF THE CITY OF ILWACO, WASHINGTON AS ADOPTED BY ORDINANCE #886 AND AMENDED BY ORDINANCE #897

WHEREAS, the City of Ilwaco adopted the 2019 budget in final form by Ordinance #886 on December 10, 2018 and amended it on July 8, 2019 by Ordinance #897; and

WHEREAS, subsequent thereto it has become necessary for the city to amend said ordinance because of revenues and council approved unbudgeted expenditures of same; and

WHEREAS, the city is desirous of amending its budget pursuant to RCW 35A.33.090.

NOW, THEREFORE, THE CITY COUNCIL OF THE CITY OF ILWACO, WASHINGTON, DOES ORDAIN AS FOLLOWS:
