CITY OF ILWACO ORDINANCE NO. 879

AN ORDINANCE AMENDING THE 2017 BUDGET OF THE CITY OF ILWACO, WASHINGTON AS ADOPTED BY ORDINANCE #869 AND AMENDED BY ORDINANCE #875

WHEREAS, the City of Ilwaco adopted the 2017 budget in final form by Ordinance #869 on December 5, 2016 and amended it on August 14th, 2017 by Ordinance #875; and

WHEREAS, subsequent thereto it has become necessary for the city to amend said ordinance because of revenues and council approved unbudgeted expenditures of same; and

WHEREAS, the city is desirous of amending its budget pursuant to RCW 35A.33.090.

NOW, THEREFORE, THE CITY COUNCIL OF THE CITY OF ILWACO, WASHINGTON, DOES ORDAIN AS FOLLOWS:

<u>Section 1.</u> The following funds contained in the 2017 Budget are hereby amended as follows:

<u>Section 3.</u> The city clerk is hereby directed to transmit this supplemental budget to the State Auditor's Office and to the Association of Washington Cities.

Section 4. Effective Date. This Ordinance takes effect and is in full force five (5) days after its passage, approval and publication of an approved summary of the title as provided by law.
