## BINGO LICENSING ORDINANCE # 1958

AN ORDINANCE OF THE TOWN OF VOLNEY, OSWEGO COUNTY, NEW YORK TO PROVIDE THAT IT SHALL BE LAWFUL FOR ANY AUTHORIZEDOURGANIZATION UPON OBTAINING A LICENSE THEREFOR TO CONDUCT THE GAME OF BINGO WITHIN THE TERRITORIAL LIMITS OF THE TOWN OF VOLXNEY, OSWEGO COUNTY, NEW YORK SUBJECT TO ALL APPLICABLE PROVISIONS OF ARTICLE 14-G OF THE GENERAL MUNICIPAL LAW OF THE STATE OF NEW YORK, AND ANY AMENDMENTS THERETO.

RESOLVED: By the Town Board of the Town of Volney, Oswego
County, New York that the following ordinance, to be known as the
"BINGO LICENSING ORDINANCE" - 1958, be adopted as an ordinance of the
Town of Volney, upon the terms, and in the manner following:

SECTION 1. Definitions. The terms "Bingo" or "Game", "Authorized Organizations" and "License" as referred to in this ordinance shall have the same meanings as defined in Section 476 of Article 14-G of the General Municipal Law of the State of New York.

SECTION 2. It shall be lawful for any authorized organization upon obtaining a license therefor, as provided in Article 14-G of the General Municipal Law and any amendments thereto, to conduct the game of Bingo within the territorial limits of the Yown of Volney, subject to the provisions of this ordinance, the provisions of said Article 14-G of the General Municipal Law of the State of New York, and the provisions of Article 19-B of the Executive Law of the State of New York and any amendments thereto.

SECTION 3. Restrictions upon the conduct of Bingo games authorized by this ordinance:

1. No person, firm, association, corporation or organization, other than an authorized organization licensed under the provisions of this article, shall be permitted to conduct such games.

- 2. The entire net proceeds of any game shall be exclusively devoted to the lawful purposes of the organization permitted to conduct the same.
- 3. No single prize shall exceed the sum or value of two hundred fifty dollars.
- 4. No series of prizes on any one occasion shall aggregate more than one thousand dollars.
- 5. No person except a bona fide member of any such organization shall participate in the management or operation of such game.
- 6. No person shall receive any remuneration for participating in the management or operation of any such game.
- 7. The unauthorized conduct of a bingo game and any wilful violation of any provision of this ordinance shall constitute and be punishable as a misdemeanor.

SECTION 4. This ordinance shall become operative and effective upon its approval by a majority of the qualified voters of the Town of Volney, Oswego County, New York voting on a proposition therefor submitted at a Special Election held within the Town of Volney, Oswego County, New York.
