### **ORDINANCE NO 1-84 – REVISED 3-13-2013**

An ordinance relating to building permits in the Town of Springfield.

The Town Board of Supervisors and Chairman of the Town of Springfield, Marquette County, State of Wisconsin do ordain as follows:

- 1. No building of any part thereof shall hereafter be erected, altered, repaired, or ground broken for same in the Town of Springfield, Marquette County, State of Wisconsin except as hereinafter provided, until a permit therefore shall have first been obtained by the owner or his authorized agent from the Town Clerk. The term "building" as used in this section shall include any building or structure of part thereof when the cost of such construction, alteration, installation, or moving, including value of one's own labor, exceeds the sum of \$1,000. It shall further be deemed to include the erection, placement, moving or location of any mobile home within the town of Springfield, other than within a licensed mobile home park. Any structure or mobile home used for a primary residential purpose shall be placed on a permanent foundation. Mobile Home Foundation may be a floating slab, ribbon slabs or pylons. Said permit shall be posted at a prominent place on the premises prior to and during period of construction, alteration, repair, or moving.
- 2. Application for building permit shall be made in writing upon form furnished by a person designated by the Town Board, and shall state name and address of the land owner and also the owner of building and/or mobile home, the legal description of the land upon which the building or mobile home is to be located and such other and further information as the Town Clerk may reasonably require.
- 3. Any building permit issued pursuant to this ordinance for a structure or mobile home shall be void 2 years from date of issuance and/or if operations there under are not commenced within 6 months of date if issuance.
- 4. The fee for a building permit as herein provided shall be the sum of \$50.00 payable to a person designated by the Town Board prior to commencement of any work, location, or moving contemplated by this ordinance.
- 5. Any person, firm, or corporation who fails to comply with the provisions of this ordinance shall, upon violation, forfeit \$200 together with mailing costs. If not paid within 60 days, said fees will be added to the tax parcel as a special charge.
- 6. No building and/or mobile home shall be located within 10 feet of a lot line.
- 7. This ordinance shall take effect upon passage and posting, except that nothing in the ordinance shall be interpreted so as to conflict with State laws or orders regarding mobile homes or mobile home parks.

- 4. The fee for a building permit as herein provided shall be the sum of \$20.00 payable to the Town Clerk prior to commencement of any work, location, or moving contemplated by this ordinance.
- 5. Any person, firm or corporation who fails to comply with the provisions of this ordinance shall, upon conviction thereof forfeit not less than \$25.00 and no more than \$100.00 together with costs of prosecution for each such violation, and default of payment thereof shall be imprisoned in the County Jail of Marquette County, State of Wisconsin until such forfeiture and cost shall be paid, but not exceeding 60 days. Each day during which a violation of the provisions of this ordinance shall be permitted to exist shall be deemed a separate and distinct offense.
  - 6. No building and/or mobile home shall be located within 10 feet of a lot line.
- 7. This ordinance shall take effect upon passage and posting, except that nothing in this ordinance shall be interpreted so as to conflict with State laws or orders regarding mobile homes or mobile home parks.

- 4. The fee for a building permit as herein provided shall be the sum of \$5.00 payable to the Town Clerk prior to commencement of any work, location, of moving contemplated by this ordinance.
- 5. Any person, firm, or corporation who fails to comply with the provisions of this ordinance shall, upon conviction thereof forfeit not less than \$25.00 no more than \$100.00 together with costs of prosecution for each such violation, and default of payment thereof shall be imprisoned in the County Jail of Marquette County, Wisconsin until such forfeiture and cost shall be paid, but not exceeding 60 days. Each day during which a violation of the provisions of this ordinance shall be permitted to exist shall be deemed a separate and distinct offense.
