ORDINANCE # 2

AN ORDINANCE ESTABLISHING A MONTHLY PARKING FEE FOR MOBILE HOMES AND FOR LICENSING TRAILER CAMPS.

SECTION 1. The provisions of 66.058 of the Wisconsin Statutes, and the definitions therein contained are hereby adopted by reference.

SECTION 2. There is hereby imposed on each occupied non-exempt Mobile

Home located in the Town of Springfield, Marquette County, Wisconsin, a

parking permit fee of \$ 10000 per month or portion thereof as determined in accordance with Section 66.058 of the Wisconsin Statutes; said

fee shall be paid to the Town of Springfield Treasurer on or before the last
day of the month for which such fees are due.

SECTION 3.

- (a) It shall be unlawful for any person to establish, operate or maintain, or permit to be established, operated or maintained, upon any property owned, leased, or controlled by him, a trailer camp within the limits of the Town of Springfield, without first having obtained a license for such amp from the Town Board pursuant to this ordinance. Such license shall expire one year from the date of issuance, but may be renewed under the provisions of this ordinance for additional periods of one year.

use and benefit and may be prosecuted and recovery had thereon by any person who may be injured or damaged by reason of the licensee violating the provisions of this ordinance. The annual fee for Trailer Camp license shall be Twenty Five (\$25.00) Bollars, payable in advance, except as to such licensees of Trailer Camps operating under license by the Wisconsin State Board of Health.

SECTION 4.

- (2) Every trailer or trailer camp shall be located on a well-drained area, and the premises shall be properly graded so as to prevent the accumulation of storm or other waters. No trailer or other camp shall be situated in any area that is located so that drainage from barnyard, outdoor toilet or other source of filth can be deposited in its location.
- (b) No trailer unit shall be parked in a camp outside of a designated space.

SECTION 5.

Every licensee of a trailer camp shall comply with the sanitary provisions of Wisconsin Statutes 66.058, the rules of Wisconsin Department of Health and the ordinances of the Town of Springfield.

SECTION 6.

There shall be imposed on each owner or operator of a Trailer Camp licensed herein a monthly parking permit fee of \$ _______ as determined by Section two (2) of this ordinance on each occupied non-exempt trailer which shall have been parked in such camp at any time during the month.

It shall be the full and complete responsibility of the licensee to collect the proper amount from each trailer and to pay the Town Treasurer such monthly parking permit fees on or before the 10th day of the month following the month for which such fees are due.

SECTION 7.

The licensee of a mobile home park or trailer camp shall not be required to collect for any space occupied by a mobile home accompanied by an automobile if said mobile home and automobile bear license plates issued by any other than this state for an accumulated period not to exceed sixty (60) days in any twelve months, of if the occupants of the mobile home are non-residents tourists or vacationists. When one or more persons occupies mobile home are employed in this state there shall be no exemption from the monthly parking fee.

SECTION 8.

Any person violating any of the provisions of this ordinance shall upon conviction thereof forfeit not less than Ten Bollars (\$10.00) nor more than \$25.00 and costs of prosecution and in default of payment of such forfeiture and costs shall be imprisioned in the countyjail until payment of such forfeitures and costs, but not exceeding ten days for each violation.

SECTION 9.

If any section, paragraph or sentence of this ordinance is held invalid by any court of competent jurisdiction, such portion shall be deemed a separate, distinct and independent prevision and such holding shall not affect the validity of the remaining portions.

SECTION 10.

This ordinance shall take effect from and after its passage and posting as provided by law.
