TOWN OF SPRINGFIELD ORDINANCE ESTABLISHING JURISDICTION AND DUTIES OF TOWN CONSTABLE ORDINANCE 98-1

WHEREAS, effective January 1,1985, pursuant to 1983 Wis., Act 532, sec. 60.22(4) the Town Board shall determine the jurisdiction and duties of the town constable,

WHEREAS, it is in the public interest and welfare to establish the jurisdiction and duties of the constable of the Town of Springfield, as provided herein.

NOW, THEREFORE, the Town Board of Supervisors, of the Town of Springfield, Marquette County does ordain as follows:

SEC 1 STATUTORY AUTHORITY:

Pursuant to sec. 60.22(4) and sec. 60.35 of 1983 Wisconsin Act 532, the Town Board of Supervisors of the Town of Springfield, Marquette County hereby establishes the jurisdiction and duties of the town constable of the Town of Springfield, Marquette County, as described herein.

SEC 2 JURISDICTION AND DUTIES:

The town constable of the Town of Springfield, Marquette County shall:

- 1. Cause to be enforced and prosecuted all violations of town ordinances of which he has knowledge or information.
 - (a) Building Permit Ordinance 01-84
- Act on behalf of the Town Board as directed to:
 - (a) See the town orders and ordinances are obeyed.
 - (b) Install Fire Signs
 - (c) Obtain necessary assistance, if available, in case of emergency, except as provided under Chapter 166 of Wisconsin Statutes for emergency government.

SEC 3 NON-EXCLUSIVITY:

A. Other ordinance.

Adoption of this ordinance does not preclude the Town Board from adopting any other Ordinance or providing for the enforcement of any other law or ordinance relating to The same of other matter.

B. Other remedies.

The jurisdiction and duties of the town constable as stated herein shall not preclude The Town Board or any other town officer from proceeding under any ordinance Or law by any other enforcement method to enforce any ordinance, regulation, or order.

SEC 4 SEVERABILITY:

SEC 5 EFFECTIVE DATE:

If any provision of this ordinance is invalid or unconstitutional, or if the application of this ordinance to any person or circumstance is invalid or unconstitutional, such invalidity of unconstitutionality shall not effect the provisions or applications of this ordinance which can be given effect without the invalid or unconstitutional provision or application.

Pollworkers: A motion was made by Jim Warzynski, seconded by Byron Henke to raise the pollworker hourly wage to \$8.00. Motion carried.

A motion was made by Byron Henke, seconded by Larry McLaughlin to raise the mileage reimbursement rate to .30/mile. Motion carried.

A motion was made by Byron Henke, seconded by Jim Warzynski to pay the Fire Inspector an hourly wage of \$8.00/hr plus mileage. Motion carried.

A motion to adjourn until next year's annual meeting on Wed April 18, at 7:30 p.m. was made by Larry McLaughlin, seconded by Terry Janke. Motion carried. Meeting was adjourned at 8:40 p.m.
