



Dear Terry,

The Marquette County Board of Supervisors passed a tentative supervisory redistricting plan based on the 2010 census. The plan now requires township action and approval of your supervisory wards.

Municipalities are allowed 60 days to adjust the plan and adopt a resolution describing ward boundary lines. The county would like to complete the redistricting with a public hearing no later than August 16th to meet state requirements. I have enclosed a sample resolution that you may use if you wish. Your municipality will be required to publish a Type A notice for two weeks and hold a public hearing followed by a municipal meeting to adopt the resolution. A copy of the signed resolution must be sent to my office. If you feel that the boundary lines adopted by the county need to be adjusted, please contact my office immediately.

The enclosed map and description of your supervisory ward boundaries is based upon 2010 Census data and input received at the public hearing held on May 17, 2011. As a result, changes to this plan are expected to be minimal.

Please contact me if you have any questions. I will be available to assist you at any time. If you wish to view the plan in more detail, please contact Jerry Smart, County Surveyor, at 297-3028. We will be happy to meet with you and discuss any issues you or other town officials may have.
