- b. Northern Current Fiscal Sponsorship
  - i. From Chris Morris: Saranac Lake Area Chamber of Commerce is doing work for Northern Current, the Rotary wants out of fiscal sponsorship. NC needs a new fiscal sponsor. Scollin raises the concern that we may become the new Rotary if we are not careful about fiscal sponsorship creep. We will table it until the next meeting. We will consider the possibilities and send any questions to Murphy, so we can address issues quickly. The governance committee needs to review pass-through policy so that we can answer this question easily in the future.
- c. Monks-Kelly resignation: Monks-Kelly submits her resignation from the SLLDC. She will attend the March meeting and help with any transition as needed.
