RESOLUTION AUTHORIZING THE VILLAGE MANAGER TO HIRE WENDEL FIVE BUGELS DESIGN FOR ARCHITECTUAL SERVICES

WHEREAS, the Village of Saranac Lake Board of Trustees has established a capital reserve fund known as the "Public Safety Facilities Reserve Fund". The purpose of which is to accumulate moneys to build and retrofit the existing police, fire, and/or public safety buildings, and,

WHEREAS, the Village of Saranac Lake received eight (8) bids for architectural services related to the public safety facilities project and the Emergency Services Building Committee reviewed the bids and unanimously recommends Wendel Five Bugels Design for the contract, and,

WHEREAS, the use of any funds from the Capital Reserve Fund is subject to Permissive Referendum.

RESOLVED, that the Saranac Lake Village Board of Trustees hereby directs the Village Manager to execute a contract with Wendel Five Bugels Design for the aforementioned services, funded via a \$39,760.00 expenditure from the emergency services building capital reserve fund,

BE IT FURTHER RESOLVED, that the Village Clerk is authorized to make public notice for the intended use of the reserve subject to a Permissive Referendum

BE IT FURTHER RESOLVED, that any unspent funds resulting from this \$39,760.00 capital reserve fund expenditure be returned to the Public Safety Facilities Reserve Fund and any expenditure in excess of this resolution's appropriation is subject to board approval and permissive referendum.
