**SLICFIBER SERVICE AGREEMENT**

THIS TELECOMMUNICATION SERVICE AGREEMENT ("Agreement") made effective on the 28 of November, 2023 ("Effective Date") by and between SLICFIBER., a New York corporation with an office and principal place of business at 3330 SH 11B, Nicholville, NY 12965 ("Slic") and Village of Saranac Lake ("Customer"). Slic and Customer may also be referred to herein as "Party" and/or "Parties", as appropriate.

1. **Scope of Services:** As applicable. Pursuant to the provisions of this Agreement effective as of the Effective Date, Customer shall purchase local, regional toll, long distance, internet access or IPTV telecommunications service from Slic as indicated on Schedule A, attached hereto and made part, hereof, ("Services") for the term set forth in Section 3 of this Agreement. Customer hereby authorizes Slic to notify Customer's current telecommunications services provider(s) of such changes and to take all action necessary to make such changes. This Section 1 constitutes Customer's letter of authorization for Slic to act as its agent to effect such changes. Under no circumstances will Slic be responsible for payment of Customer's current telecommunications services provider(s) cancellation or termination fees.
2. **Term of Services:** Subject to the provisions of Section 2 of Schedule B - Slic Standard Terms and Conditions of Service, which Schedule is referred to herein and made a part hereof, the term of this Agreement shall begin on the date of installation.
3. **Rates and Payment for Services:** Subject to the provisions of Section 3 of Schedule B, the rates for Slic Services during the Term are set forth on Schedule A, attached hereto and made a part hereof.
