## RESOLUTION TO SUPPORT PENDRAGON THEATRE'S ADIRONDACK PARK COMMUNITY SMART GROWTH GRANT APPLICATION

WHEREAS, the NYS DEC, in cooperation with the Department of State and Adirondack Park Agency, is soliciting smart growth grant applications from Adirondack Park communities and organizations and

WHEREAS, DEC seeks proposals for capital projects and community development initiatives that link environmental protection, economic development and community livability within the special conditions of the parks; and

WHEREAS, Pendragon Theatre is a non-profit professional theater based in Saranac Lake and is an important anchor institution for the arts; and

WHEREAS, Pendragon seeks to relocate to Downtown Saranac Lake and renovate and occupy an existing building; and

WHEREAS, The Village of Saranac Lake is partnering with the Pendragon Theatre to submit an Adirondack Park Community Smart Growth Grant Application for water management, environmental remediation, and environmentally-sensitive construction needed in order to move the theater to the new Woodruff Street location.; and
