**SARANAC LAKE VILLAGE BOARD OF TRUSTEES
RESOLUTION APPROVING INCLUSION
OF \$15,318.66 FOR TEAMSTER COMPENSATION INTO
THE ANNUAL OPERATING BUDGETS FOR FISCAL YEAR 2022- 2023, AND
ELIMINATION OF SECOND POSITION CODE ENFORCEMENT/
DEVELOPMENT ADMINISTRATOR**

WHEREAS, the Village of Saranac Lake recognizes the value of our Teamster union staff, and;

WHEREAS, the Village of Saranac Lake Board of Trustees intends to increase wages and compensation for technical licensing, and;

WHEREAS, the Village of Saranac Lake Board of Trustees finds that it is in the best interest of the Village to eliminate the second position Code Enforcement Officer/Development Administrator that was created in 2017, and further provide that all duties and responsibilities shall be performed by the Code Enforcement Officer and Community Development Director.

NOW, THEREFORE BE IT RESOLVED, the Village of Saranac Lake Board of Trustees hereby approves the addition of \$15,318.66 to the operating budgets for the 2022 – 2023 Fiscal Year, for increased Teamster wages and technical licensing compensation. And eliminates the second position Code Enforcement Officer/Development Administrator.
