- 2 Bids must be detailed categorically in the same order as specification to facilitate reading and study.
- 3 The bidder must be a duly authorized representative of the company he represents for a period of at least one year.
- 4 If the bidder proposes to modify a product or service as to make it conform to the requirements of the Invitation for Bids, he shall (a) include in his bid a clear description of such proposed modifications, and (b) clearly mark any descriptive material to show the proposed modifications.
- 5 Modifications proposed after bid opening to make a product or service conform to the specifications will not be considered.

Preparation (pressure washing) of an approximately 10,300 square foot roof of the village central garage building as necessary to receive two-inches (2") (nominal, plus or minus ½") of 2.7 pound per cubic foot closed cell roof foam (Gaco Western Roof Foam, or equivalent) over the entire roof, sealing all penetrations and voids as well as installing a minimum of 60 mils of Versaflex, VF380 polyurea (or equivalent product) over all roofing foam sealing to penetrations and existing flashings.

Total for proposal Item # 1 including labor and materials:

\$115,875.00

Credit for pressure washing roof by others prior to work commencing: -\$3,500.00

This proposal includes a lifetime warranty on materials from the manufacturer and a 3 year warranty on labor and materials from North Country Spray Foam.

This proposal includes all debris removal and disposal costs.

Air temperature must be above 60° (or at least 5° above dew point temperature), and roof must be completely dry, with a substrate moisture content at or below 16% in order for work to proceed.
