WHEREAS, the Village Board of Trustees desires to adopt the Food Truck Law, and,

WHEREAS, the Village Board of Trustees held a public hearing on June 12, 2023 to consider the adoption of the Food Truck Law, and,

WHEREAS, the Board must consider the impacts of all proposed actions in accordance with the State Environmental Quality Act (SEQR), prior to taking any action all proposed actions.

WHEREAS, the Board has determined that adoption of the Food Truck Law a Village Code of Saranac Lake is a type I action for the purposes of SEQRA, and,
