#### **APPROVAL OF MINUTES**

Chair, Elias Pelletieri opened the meeting at 5:00pm.

Motion to approve June 21, 2022 Regular Meeting Minutes by Paul Herrmann, seconded by Pelletieri. Pelletieri asked for a Roll Call Vote.

## 1) McEneany review of Minor two lot subdivision
