RESOLUTION TO ESTABLISH THE VILLAGE OF SARANAC LAKE HOUSING TAKS FORCE

NOW, THEREFORE BE IT RESOLVED, the Board of Trustees hereby establishes a Housing Task Force to track progress, assist with completion of action items, and study best practices and successful strategies for housing development; and

BE IT FURTHER RESOLVED, that voting members of the Housing Task Force do not exceed (10) individuals and appointments to the Task Force require a majority vote of the Village Board; and

BE IT FURTHER RESOLVED, the Board of Trustees appoints the individuals listed below to the Housing Task Force for a term of two-years; and

BE IT FURTHER RESOLVED, that Melinda Little is appointed as the Housing Task Force Coordinator for a term of (1) year due to her experience with the Housing Work Group and dedication to housing issues. The Coordinator will report to the Community Development Director. Duties of the Coordinator include: schedule and attend meetings, maintain meeting notes, and monitor tasks.
