Bills not paid within the 10 days of request for payment by the Town shall accrue interest at the rate of 6% per year. Further, if I fail to pay said amounts when due, then the Town may certify such costs against any property owned by me within the Township limits for collection with the real estate taxes and/or take necessary legal action to recover such costs and I agree that the Township shall be entitled to attorney's fees and other costs incurred by the Town as a result of such legal action. I knowingly and voluntarily waive all rights to appeal said certification of such expenses against my property under any applicable Minnesota Statutes.
