**A RESOLUTION TO CERTIFY RESULTS OF THE TUESDAY, NOVEMBER 5, 2024  
GENERAL ELECTION AFTER RECOUNT  
(Canvass Election)**

**WHEREAS**, the Town of Baldwin held a municipal election for the office of Mayor and four City Council members on Tuesday, November 5, 2024, during the General Election; and,

**WHEREAS**, on November 8, 2024 the Town Board canvassed the results and adopted Resolution 24-41; and

**WHEREAS**, candidate Chase Springman thereafter requested a recount of the votes for the 4 year term of City Council member pursuant to Minn. Stat. § 204C.36; and

**WHEREAS**, Baldwin Township converted to the City of Baldwin when Mayor Jay Swanson and the successful City Council members for the 2 year term were sworn into office on November 18, 2024; and

**WHEREAS**, the City conducted the requested recount of the votes for the 4 year term of City Council member on November 20, 2024; and

**WHEREAS**, The Clerk/Treasurer has prepared a summary of the returns of the forenamed recount for City Council member 4 year term; and

**WHEREAS**, the City Council must canvass the municipal election returns and declare the results after the election.

**NOW, THEREFORE BE IT RESOLVED**, by the City of Baldwin, following recount for the City Council member 4 year term, all returns are hereby canvassed and the following is declared the official results of the November 5, 2024 election.


