Commissioners Address Revitalization Concerns

In an initiative designed to make Cameron more pleasing to current residents as well as more appealing to potential new businesses and residents, the town Board of Commissioners is (among other actions) throwing support behind the Beautification Committee's "Clean Up Cameron" campaign, choosing "Welcome to Cameron" banners to fly from light poles, and taking a fresh look at enforcing or modifying ordinances that have sometimes been overlooked. The Board "will work to identify the community's most pressing revitalization concerns," according to Commissioner Joey Frutchey.

Current town ordinances that address problems such as unlawful junk storage, abandoned vehicles, noise, open burning and animals could be enforced "through the use of a third party enforcement agency or notice from the town," he said.

Planning Board Tables Subdivision Decision

Cameron's Planning Board voted on July 20 to continue the discussion of a proposed 86-acre subdivision on NC 24/27 at its next meeting on August 8. The developers, Bobby Branch of Bobby Branch Tree Removal & Sons and Michael Blakely of Drafting & Design LLC, would build 57 homes on 40,000-square-foot lots. The estimated cost of the homes is \$400,000. About 20 acres of wetlands on the parcel, which is now farmland, would remain open. The plan has sparked local opposition due to its density and the potential impact of so many new homes on such a small town.

As the town planner was unable to attend the July 20 meeting, the Board decided to defer making a recommendation.

YARD DEBRIS PICKUP RULES

The town picks up yard debris on Tuesday and Thursday. Please check the town website to be sure you are meeting the requirements for pickup, e.g. loose leaves must be bagged or in a container and limbs can be no longer than 6 feet and no greater than 3 inches in diameter. The town maintenance technician will not pick up any yard debris that has been hauled in from out of town. Yard debris pickup will be suspended October 1-April 1 to allow residents to burn.

Event Venue Possible with State Grant Funds

Cameron was recently awarded a \$400,000 grant from the state's Rural Transformation Grant Fund for the purpose of acquiring land beside the Phillips Memorial Park for additional parking for the Park and construction of an event venue.

The grant was written by Lindsay Whitson, a grant writer with Triangle J Regional Council. Cameron participates in the Council's Grant Assistance Program. The amount originally applied for was \$650,000.

The idea was to purchase six acres on the corner of Pineywood Church Road and NC HWY 24-27 adjacent to the Park from Ann McCracken and construct a "Dewberry Barn" (similar to the Fair Barn in Pinehurst) which could be rented out for events such as weddings, generating revenue for the town. As the grant on offer is significantly lower, the discussion now is how the town can create an attractive venue that provides revenue...funds that would be used to maintain the venue and to help with groundskeeping in the Park.

The town must have a signed contract with the state, setting forth in detail what the town intends to do with the grant, by August 31 in order to proceed with the grant. Construction bids would then go out in late summer/early fall.

Historic District

After months of work by the Historic Preservation Commission (HPC), including an inventory of the town's surviving historic structures, Cameron's Historic District was officially designated as such by the state on May 22. Following a May 23 public hearing at which the Board of Commissioners voted to adopt the designation, it is now registered as a local district at the county, state, and national level. Property owners must now file an application at Town Hall before changing the exterior appearance of any building in the district. The HPC will determine on the proposed changes' appropriateness based on published standards.

The district currently extends from the railroad tracks to the Business Rte. 1 overpass. A map showing the district and the structures it includes, as well as information about HPC guidelines, are available at Town Hall.

Commissioners Want to Hear from You

The Town Board of Commissioners is looking for feedback from members of the community regarding what they want for the town going forward. To this end, there is now a suggestion box at Town Hall where if anyone can drop in a comment, thought, idea or suggestion—anonymously, if you choose.

The effort includes the sale of tee shirts and hats with a historic design as well as frame-able prints of historic Cameron. Cameron Town Clerk Wendy Butner has received recognition for her work to improve town water quality.

Matt Casto of the North Carolina Rural Water Association presented the Administrative Excellence Award to Wendy at a recent Cameron Commissioners meeting, citing her "outstanding service to the water and wastewater industry."

Casto provides technical assistance to water systems in need, a service Cameron benefited from last year when one of the two town well had higher concentrations of manganese and iron than the allowed EPA standard.

When the issue was addressed this past fall, daily testing of the well was needed to monitor the water quality. Wendy did this every morning.

She has also taken a water class to further her education and skill set in order to serve the town's various needs.
