## **Town Water Update**

To address water quality issues, The Town has been working with Bill Lester, an engineer for LKC Engineering; Tommy Overby from NC DEQ; Matt Casto and Keith Buff from NC Rural Water Association, and Bill's Well Drilling. The Board of Commissioners has approved a quote for the media replacement at Well 8; hopefully this will begin soon and will eliminate any iron and manganese.

The water being produced is of good quality and clarity, due mostly to correcting some operating systems, primarily the relocating of the chlorinator. The Emergency Interconnection with Moore County is planned to start in September, with Atkinson Infrastructure being awarded the project. Meanwhile the Board of Commissioners has voted to hire a new ORC (Operator in Responsible Charge) for the town water system; he is William Baker, will be the acting ORC until our maintenance tech, Jason Carlyle, becomes certified.

## Street Fair Will Be Sept. 30 & Oct. 1

The two-day Antique Street Fair takes place this fall on Friday, Sept. 30 and Saturday, Oct. 1. Dealers may begin setting up at 8 a.m. on Thursday.

The deadline for obtaining a permit is 4 p.m. on Thursday Sept. 29. Business and property owners who rent vendor spaces must register at the Town Hall, providing their name, address and phone number for vendor referrals. This information will also be posted on the town website.

Participating businesses and property owners are also responsible for verifying that the vendors they host are selling items that conform to the conditions stated in the permit. Food vendors must register with the Board of Health 15 days before the event.
