Water Bill Postage Surcharge Coming

Beginning with January 2026 Utility Billing, there will be a \$2 fee for mailed paper bills. Each year the Town spends more than \$1700 on postage alone. You can save the \$2 by providing your email address to Town Hall, enabling your monthly statement to be emailed instead of mailed through USPS.

Applications for Historic Plaque Discount Still Open!

The non-profit Cameron Historic Preservation Inc (CHP) expanded its plaque program (launched with an initial set of 10 last year) this fall. The 8x10-inch cast bronze markers have a raised inscription honoring each of our town's historic structures. (At right is a plaque currently identifying a commercial building.)

In addition to markers for Cameron's five historic churches, this round opens the program to residential structures for the first time. Historic District homeowners who would like a plaque can obtain a simple application form at Town Hall or via email at cameron.com.

The first five applicants will be entered into a drawing for one free plaque in this cycle, while the remaining four will receive a 50 percent discount on the \$465 cost of the bronze marker, a reduced price of \$230. Thanks for helping us highlight Cameron's history!
