PERMITS ARE REQUIRED FOR THE FOLLOWING:

- All new 1 and 2 family homes
- Additions that increase the physical dimensions of a building
- Alterations to the building structure
- Alterations to the building's heating, electrical or plumbing systems
- All electrical wiring (new or remodeling)
- All HVAC (new or remodeling)
- All plumbing (new or remodeling)
- Agricultural buildings/Commercial buildings
- Accessory Structures (detached garages, pole buildings, sheds)
- Re-siding or Re-roofing
- Handicap ramps
- Decks
- Fences

PERMITS ARE NOT REQUIRED FOR THE FOLLOWING:

- Maintenance including floor covering, drywall, interior finishing
- Installation of cabinetry without plumbing or electrical
- Repairs deemed minor by Building Inspector or Village
- Normal repairs to HVAC and plumbing
- Repairs to electrical equipment or systems (e.g. switches, receptacles or fixtures)

TO OBTAIN AN APPLICATION

- Call the building inspector to have applications mailed, pick up applications at the Municipal Center or download from the Village website at http://www.biron.wi.gov/permitsforms
- Please see the attached list of information required to obtain building permits
- Permit fees are determined according to the Village Fee Schedule
- Any work done prior to obtaining a building permit will result in permit costs being doubled

WHAT DO I NEED FOR A BUILDING PERMIT?

NEW HOMES

- 1. 2 sets of building plans drawn to scale with elevations
- 2. Site plan of the land showing dimensions of the property, size of all structures on property and distances from structures to lot lines and ordinary high water mark (if applicable). Also show percentage of lot coverage calculations and mark location on property.
- 3. Thermal performance sheets (heat loss calculations)
- 4. Wall bracing detail plan
- 5. Uniform Building Permit application
- 6. Erosion control plan workshop and plot plan
- 7. Zoning permit application
- 8. Shoreland protection district permit if applicable
- 9. Permit fee amounts from the fee schedules
- 10. Driveway permit application (if applicable)

ADDITIONS, REMODELS & ACCESSORY STRUCTURES OVER 150 SQUARE FEET

- 1. 1 set of building plans drawn to scale with elevations
- 2. <u>Site plan</u> of the land showing dimensions of the property, size of all structures on property and distances from structures to lot lines and ordinary high water mark (if applicable). Also show percentage of lot coverage calculations and mark locations on property.
- 3. Sanitary permit (if applicable)
- 4. Uniform Building Permit application

- 6. Zoning permit application
