## August 16, 2017

- I. Meeting unofficially called to order by Jerry Olson at 7:00 pm. Gordon Awsumb is not present, temporary Chair needs to be appointed. Zwald nominates John Pietenpol, Jeanne Williams seconds, all in favor. John Pietenpol called the meeting to order.
- II. Roll Call: Jerry Olson, Jeanne Williams, John Pietenpol, Candace Bettendorf and Nicky Thompson, clerk.

- V. Approve Minutes: *Motion* to approve Minutes from 7/19/17, with one correction, JO/JW, all in favor, GZ abstains.

  - a. Concept map located in the SW 1/4 of the NW 1/4 and the NW 1/4 of the NW 1/4, Section 11, T28N, R18W, owners Edwin and Mary Ross, prepared by Josh Yunker. Intend to create a 1.37 Acre Outlot on the south side of Old Cemetery Road: Josh Yunker presented, Ross wants to create Outlot, possibly sell to DNR for River access. A *motion* was made to approve the concept, GZ/JW, all in favor.

- a. Certified Survey Map located in the NE 1/4 of the NE 1/4 of Section 15, T28N, R18W, for Gerald Emholtz, prepared by Joseph Granberg: Joe Granberg presented, with Tim Emholtz attending. Joe addressed three issues that were brought up in June. 1. Water flow, this was not a concern of the County in their TRT Letter dated 8/2/2017. 2. Shared driveway, meets distance and visibility standards. Granberg will draft a driveway agreement. 3. Subdivision Ordinance states 2 lots in 5 years, lot was created 6/18/2013. Only one lot can be created before June 18, 2018. A *motion* was made to set this CSM aside until June/July 2018 with no additional fees, when both lots can be created. CSM meets Plan Commission conditions, with exception of needing a driveway agreement. Agent, client and Plan Commission all agree to this plan. JW/JO, all in favor.
- b. Plan Commission Member Oaths: Olson, Williams, Pietenpol, Zwald and Bettendorf all stated and signed an updated Oath.
- c. Status of CBA: Buddy Lucero provided a "redline" and "clean" version of the CBA which was forwarded on to the members of the Plan Commission to review. Pietenpol asked how to proceed. After a discussion the Commission decided to go through the draft, with Pietenpol taking notes to take back to the City. Pietenpol is going to request a meeting with the City for September 14, 2017.
