- IX. NEW BUSINESS
  - a. Roadside spraying, Lee Chambeau 4-Control: Olson stated before comments and presentation that he was recommending that the Town Board rescind the motion to spray the ditches that was passed at the April 11, 2017 meeting. There was much discussion about ditch spraying, mapping invasive species, mowing and private mowing. Lee Chambeau gave a presentation of how spraying has helped with noxious weed control. Motion to rescind motion from April 11, 2017 to do ditch spraying MW/TA, all in favor.
  - b. Open Book, Tuesday, May 16 5:00-7:00pm Board of Review, Tuesday May 18th 5:00-7:00pm. Olson, Andersen, Wolfe and Ron Meyer, Assessor will be present at the BOR.
  - c. Town expectations of St Croix County Sheriff: Olson listed 4 areas as examples where the Town needs sheriff assistance: 1.criminal law enforcement 2. road traffic enforcement 3. road weight enforcement 4. trash enforcement. Olson offered to talk to the Sheriff's Department to discuss expectations and possibly invite the a Town Board Meeting.

- d. Ordinance/Resolution review process: Andersen stated that ordinances on the website are hard to find. He suggested the Board review ordinances at meeting to check for validity. Andersen will rename the ordinance PDFs and Board will re-visit issue in June.
