

# APPENDIX A

## PUBLIC PARTICIPATION

The Community Preservation Study Committee was formed December 1999 by order of the Tilden Town Board after working, unsatisfactorily on land planning with the Chippewa County Conservation Department and West Central Regional Land Planning for two years. The Town did not have the authority to do land planning without Village Powers which was finally granted in April of 1999. The Town was unaware of its supposed responsibility to post agendas, until a copy of the contract signed with the Chippewa County Land Conservation Department was obtained in 1999. Chippewa County Land Conservation Department kept all of the minutes of these meetings. The Town has none. These meetings led up to an open house March 13, 1999, led by Chippewa County. Since the formation of The Community Preservation Study Committee, all minutes since December 1999 and postings since April 2003 have been kept in a book entitled "Town of Tilden Community Preservation Study Committee- Volume I & Volume II." Committee members have changed somewhat over the years.
