ELECTION NEWS

The final election for this year will be held on November 8th. Polls open at 7 a.m. and close at 8 p.m. If you are not registered to vote, you may do so on election day. Please bring along an approved 'proof of residency' to register. Approved forms include your WI Driver's License, real estate tax bill, paycheck, and bank statement. If unsure, contact the clerk or visit MyVote.Wi.gov. The website is an especially useful tool. You can request an absentee ballot, check your registration status, view the current election ballot, and see your voting history.

The alterative touch screen machine called an 'Express Vote' was such a big hit that a second machine was purchased. It is extremely helpful to a voter to navigate through a ballot and alerts the voter if attempting to 'over vote' or 'under vote.' It allows a voter to go back and change their mind and finally check voted choices. After the voter is finished, they eject the ballot from the machine. All the voter's choices are listed on the ballot for a final review. The voter then deposits the 'ballot' into the tabulating machine to be counted. It is equipped with an audio headphone option. Assistance is available to explain how to use it. The regular paper ballots that are marked by a voter are also available. The voter is asked to choose which method when registering.

If you are interested in becoming an election inspector (poll worker), please leave your name and phone number at the registration table. Training is required and provided by the clerk.

On April 4, 2023, Town of Wausau voters will once again elect chairperson, two supervisors, clerk, and treasurer for a two-year term. If you are interested in running for office, paperwork can be obtained from the clerk beginning December 1, 2022. Nomination papers with at least 20 signatures need to be returned to the clerk by January 3, 2023.

IT'S ALMOST TAX SEASON

Here are a few reminders about the upcoming property tax bills:

- Need a receipt? You can access your receipt online or you can send a self-addressed, stamped envelope along with your tax payment.
- Double check that your check is written out for the correct amount and made payable to the Town of Wausau.

- The Town of Wausau Treasurer cannot accept payments after February 1, nor can she accept second payments that are due in the summer.
- Dog license: please download the dog license form on the Town of Wausau website and return it to the Town of Wausau Treasurer with a copy of the rabies certificate from your veterinary.
- You can access all your tax needs online. If you lose your bill, need a receipt, or want to check if your taxes have been paid, access this information online at: https://ascent.co.marathon.wi.us/AscentLandRecords/

BE SURE TO TEST YOUR SMOKE AND CARBON MONOXIDE DETECTOR



November 6 is day lights savings time. "Fall back" so set your clocks back by one hour. This is a wonderful time to test your smoke and carbon monoxide detectors to make sure they are working and replace the batteries if needed. If you do not have these items in your home, it is recommended purchasing and installing them as soon as possible. Please follow the instructions as to when to replace these devices. The rule of thumb is anything over 10 years old should be replaced. Both items could save your life!

WINTER IS JUST AROUND THE CORNER

With winter approaching, please be cautious when driving, watch for the snowplow, keep your garbage dumpster off the road, and avoid plowing snow across and into the road. The Town of Wausau Ordinance Sec. 58.104: Depositing Snow Removal states: *No person may push or deposit snow, or cause snow to be pushed or deposited from his/her own personal driveway or parking area into the public streets and/or alley or roadway.* Plowing snow across the road can cause unsafe road conditions as well as slush/icy conditions. To avoid receiving a fine, please refrain from plowing snow across the road.

FIRE DEPARTMENT NEWS

If you are planning to burn, only burning permits issued by the Town of Wausau Fire Department are LEGAL. The DNR permit are not acceptable.

Just a reminder you need to properly cancel a FALSE alarm with your home or business alarm system such as a fire or carbon monoxide alarm. The alarm company will need the code that you gave them. Your alarm company will call you at the number you provided. This may be an out of state number so please do not ignore it. Once you give the correct code, they will contact 911 to properly cancel the call. If you do not give them the correct code, the Fire Department will show up at your place. If you need to test your system, please call your alarm company to put the system in test mode to avoid the fire department from responding.
