#### IT'S ALMOST TAX SEASON

Here are a few reminders about the upcoming property tax bills that will be mailed in December:

- Need a receipt? You can access your receipt online or you can send a self-addressed, stamped envelope along with your tax payment to the Town of Wausau Treasurer.
- Double check that your check is written out for the correct amount and made payable to the Town of Wausau.
- No refund checks will be issued for overpayments of less than \$5.00.
- The Town of Wausau Treasurer cannot accept payments after February 1, nor can she accept second payments that are due in the summer.
- Dog licenses this year are being increased due to Marathon County increasing their fees.
- Dog license: please download the dog license form on the Town of Wausau website and return it to the Town of Wausau Treasurer with a copy of the rabies certificate from your veterinarian.

#### **FIRE DEPARTMENT NEWS**

**THANK YOU!** Thank you to everyone who came out, donated, or supported our Annual Fire Department Picnic and 5k. It was another successful fundraiser. The money raised will help pay for our new fire truck scheduled for delivery sometime in June of 2026.

The total number of calls currently for 2025 are 12 fires, 8 crashes, 3 mutual aid calls, 57 med calls, and 1 MABASA for a total of 81 responses from the Fire Dept.

**THINKING ABOUT BURNING?** If so, please visit the town website at <a href="https://townofwausau.com">https://townofwausau.com</a> for the burning ordinance. It could cost you up to \$500 if the Fire Department is called to your property for not following the

ordinance. Legal burning permits are issued by the Town only, not by the DNR. For more information or a permit contact Ben Schlund at 715/297-3396 or Dean Johnson at 715.573.1564 or you can obtain a permit at Sunset County Store 715/842-9235. We are currently working on an online option to obtain burning permits starting January 2026. Please look at the town website for the link and other updates.

FALSE ALARMS: Just a reminder to properly cancel a FALSE alarm with your alarm system such as a fire or carbon monoxide alarm. The alarm company will need the code that you gave them. Your alarm company will call you at the number you provided. This may be an out of state number so please do not ignore it. Once you give the correct code, they will contact 911 to properly cancel the call. If you do not provide the correct code, the Fire Department will show up. If you need to test your system, please call your alarm company to put the system in test mode to prevent the fire department from responding.

**VOLUNTEERS:** The Town of Wausau Fire Department is always looking for volunteers to join our team as a fire fighter, first responder, or both. Want to check out the department to see if this is something for you? We would love to have you come during a training and see what it is all about. #### **KEEPING THE RIGHT-OF-WAY CLEAN**

Over the years, the Town of Wausau has been working diligently to keep the right-of-way clear. What is the right-of-way? The right-of-way provides space for storm drainage, vehicle recovery, utility poles, and safe operation of the road. It is usually 33 feet from the center line of the road. The town has the right to mow, trim, and remove trees, brush, and other obstructions within the right-of-way to ensure safety and visibility. In order to keep the right-of-way, clear it is important the property owners do the following:

**Do not install obstructions:** Avoid placing items like fences, sprinklers, or significant landscaping within the right-of-way.

**Maintain the area:** If you wish to prevent the town from mowing or trimming along your property, keep the right-of-way area clear of trees, plants, crops, shrubs, brush and avoid planting crops in the right-of-way.

The Town Board does appreciate property owners who keep the ditch in front of their property, mowed and clean.
