When are my taxes due?

Your entire real estate tax bill or your first installment is due by January 31, 2021. If you choose to pay in installments, your first installment is due by January 31, 2021 and your second installment is due by July 31, 2021. Note that the amount of your installments might vary. If you fail to pay the correct amount, at the correct time, to the correct place, you will incur additional charges.

Where do I pay?

Would you like to replace your existing address sign to the new style pictured below?



- Highly reflective
- Visible from both sides of road

The Town of Somerset will offer residents the opportunity to replace their old address sign with the new flag style sign.

If you would like to replace your existing sign, the fee is as follows:

\$25.00 for uninstalled signs. You will need to turn the post to install the sign yourself. Please call Digger's Hotline at 811 or 1-800-242-8511 prior to any installation for safety purposes.

\$75.00 for installed signs. The Town of Somerset will install the sign for you. Due to winter, the installation will take place in the spring.

Please mail a check with the proper payment to: Town of Somerset P.O. Box 248, Somerset, WI 54025 Or drop off at the secure drop box in front of the Town Hall.

Please include your name, address for the sign order, phone number or email.

If you are installing the sign yourself, the Town Clerk will contact you to make arrangements for you to pick up your sign at the Town Hall.

No credit cards accepted. Please order by February 1, 2021.

General Information

How can I get a tax payment receipt?

Enclose a self-addressed, stamped envelope along with your payment stub and payment. If you paid online, print your receipt from the web site.

Where is my refund?

You will not receive a refund unless your payment was more than the entire amount owed. Cash refunds are not given. Refund checks will be issued to whomever paid the tax bill after the check has cleared all banks.

How are my taxes calculated?

Your tax amount is derived by multiplying the value of your property as of January 1, 2020 and the mill rate for all the taxing jurisdictions, then subtracting any applicable credits and adding any special assessments, special charges or special taxes. Please review your tax bill to see the specific information regarding the taxing jurisdictions and credits.

Who can I talk to about the assessed value of my property?

Is a dog license required?

Yes, by state law all dogs, 5 months or older, residing in Wisconsin are required to a have a current year dog license. Licenses are good for the calendar year, January 1-December 31.

What do I need to get a dog license?

You need to provide a copy of your dog's current Certificate of Rabies Vaccination, along with the enclosed dog license application and payment to the Town of Somerset. Please do not send dog licenses to the County Treas.

How much are dog licenses?

Neutered/Spayed \$10.00 NOT Neutered/Spayed \$20.00
