### When are my taxes due?

Your entire real estate tax bill or your first installment is due by January 31, 2022. If you choose to pay in installments, your first installment is due by January 31, 2022 and your second installment is due by July 31, 2022. Note that the amount of your installments might vary. If you fail to pay the correct amount, at the correct time, to the correct place, you will incur additional charges.

## We're entering the 21st century. We're going digital!

Town of Somerset has partnered with a local Wisconsin business, HeyGov, to put our municipal services online. Funding for this software is covered under the American Rescue Plan Act (ARPA).

As a resident, you will be able to access municipal services online through your phone or through a web browser. This is an exciting step for us to go digital and paperless. It will provide you with the convenience of accessing our municipal services remotely. Another benefit is having these services optimized for mobile devices. If you have a smartphone, you can download the HeyGov app for free.

Starting very soon, you will be able to fill out various forms, licenses and permit applications online and make payments.

We will start with a Dog License and a Driveway Permit application. You will also be able to pay for application fees online with any major credit card or debit card. There will be a nominal convenience fee attached to transactions that are paid with a card.

To get started, you will soon find the services of HeyGov embedded into our website. However for smartphone users, you will be able to download the app for free. Just do a search for \*HeyGov\*. It's available for iPhone users in the Apple App Store. Those with Android phones can download HeyGov from the Google Play store. Once you download the app, just select "Town of Somerset".
