ALL FEES shall be deposited with the Town or the Town's agent, before the day(s) of use.

- The non-refundable Permit Fee is \$75.00 for a person who is not a property owner in the Town of Randall.
- The non-refundable Permit Fee is \$50.00 for a person who is a property owner in the Town of Randall.
- Refundable garbage fee of \$50.00 which will be refunded after the Town's Agent is satisfied with the condition of the Town Park

A Garbage Fee shall be deposited which matches the amount of the Permit Fee. If the Town's Agent is satisfied that the User removed and/or properly deposited all garbage/waste generated from the use of

the Town Park and left the Town Park as the User found it, then the Garbage Fee shall be returned to the User. If the Town's Agent is not satisfied, then the Garbage Fee shall be forfeited to the Town.

User agrees not to appeal the decision to forfeit the Garbage Fee.

User agrees not to engage in any unlawful activity on or around the Park, and at all times to comply with the Town of Randall Ordinances. Any and all damages to the Park Property caused directly by the User or his/her designated agents, family, guests or acquaintances are the responsibility of the User. User agrees, in the event of any damage to the Park, to promptly pay for the cost of repairs to the damaged Park Property. Such repairs shall be performed by the Town of Randall or the Town of Randall's Contractor and the costs/expenses incurred for the said repairs, will be billed to the user.

User agrees to hold the Town of Randall harmless for any damage to the property of the User or to the property of his/her designated agents, family, guests, acquaintances, or other persons, while on the Park property or connected with the use of the Park.

User agrees to hold the Town of Randall harmless for any damage to the person of the User or his/her designated agents, family, guests or other person, while on the Park property or connected with the use of the Park.

User releases the Town of Randall from any and all liability which may occur as a result of the events and activities sponsored by the user's group at the Park. User agrees not to sue or file any claim against the Town of Randall, and further agrees to defend, indemnify and hold the Town of Randall harmless from any claims resulting from the user's use of the Park.

It shall be the responsibility of the User to carry any and all appropriate insurance as relates to the use of the Park.

____ Yes ____ No Town approval required if user is allowed to use grills or gridirons in Bassett Park or Randall Park. ONLY gas grills or gridirons are permitted to be used.

User agrees that there will be no alcohol or malt beverages in the Parks.
