LOCAL GOVERNMENT CHANGES

The Town of Wheaton still has the following positions vacant to be filled by qualified candidates.

- 1. Appointment of a new Town Board Chair to fill the vacancy left by Bob Sworski. This term will run until April 2025.
- 2. Appointment of a Fire Commission member for a 3-year term. This term will run until April 2027.

TOWN GOVERNMENT

The Town of Wheaton currently has three commissions (Plan Commission, Parks Commission, and Fire Commission) and from time to time can create specific citizen committees to research and analyze more strategic long term town initiatives. One important part of our commissions and committees is citizen involvement and so we are always looking for residents/property owners that want to be involved in local government.

The Plan Commission assists in the development and updating of ordinances, conditional use permits, and Town of Wheaton comprehensive plan. The Plan Commission consists of seven members: Dale Hayden (Chair), Tom Piercy (Vice Chair), Sara Hinz, Jessi Jones (Deputy Secretary), Ron Kragness, Mike McGinley, and Mary Rudd (Secretary and Town Board Representative). The term for each member is 3 years, from May 1 to April 30. Appointment to the commission is by the Town Chair, with board approval. Terms are staggered. Two members one year, two members the second year, and three members changed the third year, maintaining a consistency in the commission. If you are interested in an appointment to the Plan Commission, please contact any Town Supervisor, Chair, or Clerk to add your name to the list. *Meetings are normally once per month, on the first Tuesday, held at the Wheaton Town Hall at 6:00 pm*.

The Parks Commission aids in the development and maintenance of Wheaton Park (63 acres) and boat landing in the township. The Parks Commission consists of seven members: Ken Books (Chair), Jenny Schutte (Vice Chair), Jan Dole (Secretary/Treasurer), Becky McInnis (Deputy Secretary/Treasurer), Cesar Arauz, Mark Kohls, and Aaron VanHove. The term for each member is 7 years, from July to June. Appointment to the commission is by the Town Chair, with board approval. The terms are staggered each year, with one member's term expiring each year. If you are interested in an appointment to the Parks Commission, please contact any Town Supervisor, Chair, or Clerk to add your name to the list. Seven years is a long commitment. Some members may not be able to stay that long, which means appointments may be more often than once per year. Meetings are normally once per month, on the fourth Tuesday, held at the Wheaton Town Hall (October - March months weather dependent) and Wheaton Park Lower Pavilion (April - September months weather dependent) at 7:00 pm.

The Fire Commission consists of three members: Taylor Quinnell (Acting Chair), Jessi Jones (Secretary), and Vacant. The terms are for 3 years and staggered each year, with one member's term expiring each year. Appointment to the commission is by the Town Chair, with board approval. The Fire Commission meets quarterly, with additional meetings when necessary. The main purpose of the Fire Commission is to handle personnel matters such as conducting disciplinary hearings for fire/ems personnel. *Meetings are normally as needed, on Wednesdays, held at the Wheaton Town Hall at 6:30 pm.* If you are interested in an appointment to the Fire Commission, please contact any Town Supervisor, Chair, or Clerk to add your name to the list.

NOTICE IS HEREBY GIVEN that the Spring Election for the Town of Wheaton will be held on Tuesday, April 1, 2025 from 7:00am to 8:00pm, the following officers are to be elected:

A TOWN CHAIR, for a term of two years to succeed the term of Vacant, which will expire on the 15th day of April, 2025.

A TOWN SUPERVISOR, for a term of two years to succeed the term of Ken Books, which will expire on the 15th day of April, 2025.

A TOWN SUPERVISOR, for a term of two years to succeed the term of Carolyn Kaiser, which will expire on the 15th day of April, 2025.

A TOWN CLERK, for a term of two years to succeed the term of Scott Deutscher, which will expire on the 15th day of April, 2025.

A TOWN TREASURER, for a term of two years to succeed the term of Jan Dole, which will expire on the 15th day of April, 2025.

NOTICE IS FURTHER GIVEN that the first day to circulate nomination papers is December 1, 2024, and the final day for filing nomination papers is 5:00 p.m. on Tuesday, January 7, 2025. Contact the Town Clerk for nomination papers, or obtain them from the following website: https://elections.wi.gov/forms. You will need EL-169, Nomination Papers, EL-162 Declaration of Candidacy (properly notarized), filled out and returned. Check state statutes for requirements if there is financing of your campaign. A minimum of 20 and maximum of 100 qualified electors must sign the nomination papers with legible writing. Please read the instructions with that form.

NOTICE IS FURTHER GIVEN, that if a primary is necessary, the primary will be held on Tuesday, February 18, 2025.

Acceptable Photo ID will be required to vote at this election. If you do not have a photo ID you may obtain a free ID for voting from the Division of Motor Vehicles.

All election information and notices are handled by the Town of Wheaton Clerk.

ROADS

With 80+ miles of township roads, which is more roads to maintain than most rural townships in the state, and being 100% paved there are certainly challenges. Road replacement costs for 1 mile are \$200,000+ and we need to get 40-80 years out of existing roads based on current funding levels. We continue to pursue ways of prolonging road lifecycles along with pavement and ditch maintenance to maximize the number of improvements to the roads for the available funds.

In 2024 we utilized a new innovative maintenance process called flex-patch on 103rd Street, 33rd Avenue, and 106th Street (Boat Landing Roads). What is Flex-Patch? A highly innovative maintenance process using a blend of quality modified asphalt sealant and fibers. The unique characteristics of the sealant helps reduce

bleeding during hot weather and greatly improves low temperature flexibility. An aggregate cover material is applied for the added benefit of improving the ride of the road.

Part of the long term solution will be continued road chip seal and crack patching cycles in order to extend road lifecycles. Plus there are several other ideas being discussed and tested before just turning to a tax levy increase. In 2024 we applied for Agricultural Roads Improvement Program (ARIP) grant funding for reconstruction of 50th Avenue from 50th Street to County Highway T. We should find out in late December 2024 to early January 2025 if we received the funding award.

Plans are already in motion for 2025 road work. Big projects will consist of:

- 1. Reconstruction of 20th Avenue from 40th Street to 50th Street.
- 2. Reconstruction of 34th Street, 62nd Avenue, and 35th Street from 60th Avenue to County Highway N.

DRIVEWAY SNOW REMOVAL AND ROAD RIGHT-OF-WAY

We wanted to share with you that Wisconsin Statute 346.94(5) prohibits anyone from placing or causing to be placed upon a highway any foreign substance which is or may be injurious to any vehicle. Section 86.022 makes it a misdemeanor punishable by fine to place any obstruction in a road ditch which will impede drainage.

All of this to say, DO NOT PLOW SNOW ACROSS THE ROAD. Ridges, ice, and other materials left by this action can cause accidents, unnecessary damage to vehicles, and is illegal. Piling snow in the right-of-way can damage snowplow wings and cause other damage.

We all want our roads plowed in a timely manner and safe travels for everyone on them. Our road crew does a great job every winter helping ensure that happens! Certainly we need everyone to do their part to keep right-of-ways clear and our plow trucks on the road when they are needed most. Thank you for your understanding and cooperation as we get into the winter season!

FIRE DEPARTMENT

We presently have 30 volunteers on the roster. We would like to have closer to 40 volunteers actively participating in this rewarding activity. Most calls are for things other than structure fires. Off road rescues, car crashes, snowmobile incidents, downed power lines, searches, water incidents, and brush fires are just a few of the things dealt with. Medical first responding is the largest part of the fire department responses, with transport ambulances and paramedics coming from Eau Claire or Chippewa Falls. Call the fire station or contact any member of the fire department for more information. The department is a paid-per-call, all-volunteer department. The fire station is at 3900 38th St, Elk Mound and is within the Wheaton Park. It is not a manned station. If you have an emergency, **dial 911 to contact the County Dispatch center**. They page out the firefighters as needed. For non-emergency calls, only, you can dial 715-874-6597 and leave a message. **A return call or action will be made as soon as possible.** You may also send a message to the department through Facebook.

BURNING PERMITS

Burning permits are not required in Wheaton, but you can only burn what is allowed by state law. Visit the Wisconsin DNR website at https://dnr.wi.gov/topic/openburning/ for burning regulations and several fine articles about the alternatives to burning.

- 1. and click on Chippewa County.
- 2. Drive past Wheaton Park / Wheaton Fire & Rescue frontage road sign along Wisconsin 29 South Frontage Road. This is checked and maintained daily.
- 3. Follow Wheaton Fire & Rescue on Facebook.

If you burn, please be careful. You can be responsible for all costs associated with a fire that you started if it has gotten out of control. Burn only when sufficient moisture exists (rain and/or snow cover) in the area, winds are light (under about 7 mph maximum gusts), and temperatures are cool.

CLEAN AND SAFE DRINKING WATER

The Town of Wheaton has had a long-standing history of monitoring wells and testing for toxins. The Town of Wheaton's goal is to support clean drinking water for everyone in the township.

New science and technology assists in finding facts. We all know that the more data we have; we are able to give a broader picture. On Saturday November 9, 2024, Town of Wheaton supervisor Carolyn Kaiser and acting chair Alice Droske, in collaboration with the Chippewa County Land Conservation Department and Forest Management Dept., Lynda Schweikert and Chippewa County Public Health Kristen Walters, Environmental Health Specialist provided opportunity for residents to have their water tested for nitrates free! If the nitrate test was above 8 PPM a free test was offered. Other testing was also available. We are grateful that over 75 people came. Shout out "THANKS" to those who came! Options for improving their drinking water were given to residents as they wanted. Handouts were offered and a display showed the different illnesses that can affect especially children, persons with immune disease, and elderly.

Due to the Town of Wheaton sponsoring a well sampling since 2019 (except 2020 during the pandemic) a baseline was obtained. This information became critical when Chippewa County received funding through the American Rescue Plan. The Town knew that a community well would benefit all the residents. That foresight brought the Town of Wheaton to the 'table' on day one. We were the only township to go through the many steps it takes when you're 'first'. The Department of Land Conservation and Forest Management Director Schweikert and County Board Land Conservation Chair Ken Schmitt made sure steps were completed. Thanks to the tenacity at U.W. Stevens Point (Groundwater Education Specialist), environmental engineers, DNR, and Geologists for all their expertise. Yes, after years in the making it is a reality. The community well opened on November 6, 2024.

The Community Well is located in Wheaton Park, near the pickleball/tennis court. The Elkay pump keeps a monitor of uses. When the water drains, it goes below the frost line, meaning one can obtain water from there 12 months a year. It is enclosed with a small roof, to protect the pump and yourself from the elements. If your nitrates are high, the County Land Conservation office will give you a container during courthouse open hours.



The goal is to continue to offer expanded testing, due to the high nitrate levels. Boiling water will not reduce nitrate levels. In fact, it could make the level of nitrate slightly higher because some of the water will evaporate, however, the nitrate will remain. If the nitrate level at your home is 10 mg/L or above and people in the home drink that water, you are then susceptible to blue baby syndrome, thyroid disease, increase of colon cancer, diabetes and certain other types of cancers.

We recommend annual testing of your water, as groundwater can change!!

There are multiple ways to address nitrates in groundwater. Some can be quicker and more expensive while others could require more time and less expense. There is no one solution that will solve every groundwater issue experienced.

Keep an eye on the TOWN OF WHEATON website. Click on Government, then Groundwater Information. You will see links to groundwater testing, nitrate levels map, and other resources with regards to clean groundwater.

DOG LICENSE INFORMATION: (See Real Estate Tax info below for further info)

Per Wisconsin Statute, all of your dogs over five months of age must be licensed. The annual fee for licensing is as follows:

Spayed or neutered dogs - \$8.00 Unspayed or unneutered dogs - \$13.00 Multiple dogs for up to 12 tags (for kennels) - \$60.00 Each additional tag for multiple dogs in excess of 12 -\$7.00

Per Town of Wheaton ordinance, each household is permitted up to five dogs.

PROOF OF CURRENT RABIES VACCINATION IS REQUIRED. WITHOUT PROOF OF RABIES VACCINATION, A LICENSE WILL NOT BE ISSUED.

PENALTIES

You will be charged a minimum late fee of \$25.00 for each dog five months of age or over who is unlicensed by April 1st of each year, or within 30 days of acquiring ownership on or before the dog reaches licensable age. If you fail to have your dog vaccinated against rabies as required by statute, you may be required to forfeit not less than \$50.00 or more than \$100.00.

THE WISCONSIN STATE STATUTES REGARDING THE RESPONSIBILITIES OF DOG OWNERSHIP IS AS FOLLOWS:

- (1.) Dogs more than 5 months of age shall be licensed by April 1 of each year or within 30 days of ownership of a dog 5 months of age or older, or a late fee of \$25.00 shall be imposed.
- (2.) Proof of rabies vaccination is required before a license will be issued.
- (3.) Dogs are not allowed to run at large. All dogs must be kept on the owner's premises and under the control of the owner or some other person.
- (4.) Dogs running at large are subject to impoundment.
- (5.) If the owner permits a dog to run at large, the owner shall forfeit not less than \$25.00 or more than

\$100.00 for the first offense and not less than \$50.00 nor more than \$200.00 for subsequent offenses.

(6.) The dog owner can be held liable for a dog causing injury to a person, domestic animal, or property. The penalties imposed can be from \$50.00 to \$500.00, depending on the circumstances. The penalties are in addition to any other liability imposed on the owner of the dog.

If you are a landowner and have tenants who are dog owners, please forward this information to them. Thank you.

Please do NOT mail the first half or full payment property tax payment to the Chippewa County Treasurer *BEFORE* the January 31, 2025 date. Should this happen, the Chippewa County Treasurer's office then has to mail your payment back to the Town of Wheaton Treasurer for processing.

<u>The second payment</u>, if there is a second payment; the County Treasurer will mail you a tax statement regarding the remaining amount owed, which needs to be paid on or before July 31, 2025. Please make the second payment check payable to:

TOWN PARK

The Wheaton Town Park is your one stop for Winter fun! From sledding to ice skating to snowshoeing to snowmobile trail access. It is located at 3900 38th Street, Elk Mound. A second park entrance is located right across the street from 3601 40th Street, Elk Mound. Improvements continue to be made as volunteers and funding becomes available. In 2024 the following improvement projects were completed at the park:

- For Earth and Arbor Day this year a collaborative project between Elk Mound School District 4th Grade classes, Parks Commission, Plan Commission, and Department of Natural Resources brought 100+ new pine trees to the 40th Street field. Students were able to learn about trees, planting techniques, mulching, and caring for trees after being planted.
- Volunteers assisted with Butterfly Garden maintenance to ensure a healthy habitat for our park monarchs.
- Donations were received for trees, bush, and engraved brick additions. All trees and the bush have been planted. We will be adding the engraved bricks near the lower concession building in 2025.
- This year we were again fortunate to receive another boy scout eagle project in the park. Scouts must raise 100% of the project funds through their own fundraising efforts and any project funds left over are given to the Town of Wheaton to offset future maintenance costs.

 - o Mason Books's Eagle Scout Project was adding 2 portable pickleball courts on the tennis court and renovating the basketball hoops. This brings an exciting new recreation opportunity to Wheaton Park while allowing the area to be utilized for all 3 recreation opportunities: Tennis, pickleball, and basketball!






We greatly appreciate and thank all the volunteers and community groups that make Wheaton Park such a gem in our community. Thank you!

PLEASE NOTE: Snowmobile trail no longer runs past the Wheaton Fire Station and crosses State Highway 29.




