#### **LOCAL GOVERNMENT CHANGES**

January 2024 brought some unexpected changes to the Town of Wheaton local government.

- 1. Town Chair Bob Sworski resigned and since then the position has remained vacant as the Town Board continues searching for candidates to fill the remainder of the term until April 2025.
- 2. Alice Droske as Town Vice Chair has continued to handle Town Chair responsibilities during this time period. The Town Vice Chair is selected from the existing Town Supervisors.

If you are interested in becoming the Town Chair please do the following:

- 1.) Contact any of the Town Supervisors or Town Clerk for consideration of appointment.
- 2.) Submit your resume via email to Town Supervisors and Town Clerk ahead of time or bring 5 copies to the Town Board Meeting being held on July 9, 2024 at 7PM.
- 3.) All candidates must attend the Town Board Meeting being held on July 9, 2024 at 7PM.

#### TOWN GOVERNMENT

The Town of Wheaton currently has three commissions (Plan Commission, Parks Commission, and Fire Commission) and from time to time can create specific citizen committees to research and analyze more strategic long term town initiatives. One important part of our commissions and committees is citizen involvement and so we are always looking for residents/property owners that want to be involved in local government.

The Plan Commission assists in the development and updating of ordinances, conditional use permits, and Town of Wheaton comprehensive plan. The Plan Commission consists of seven members: Dale Hayden (Chair), Tom Piercy (Vice Chair), Mary Rudd (Secretary - Town Board Representative), Jessi Jones (Deputy Secretary), Sara Hinz, Ron Kragness, and Mike McGinley. The term for each member is 3 years, from May 1 to April 30. Appointment to the commission is by the Town Chair, with board approval. Terms are staggered. Two members one year, two members the second year, and three members changed the third year, maintaining a consistency in the commission. If you are interested in an appointment to the Plan Commission, please contact any Town Supervisor, Chair, or Clerk to add your name to the list. Meetings are normally once per month, on the first Tuesday, held at the Wheaton Town Hall at 6:00 pm.

The Parks Commission aids in the development and maintenance of Wheaton Park (63 acres) and boat landing in the township. The Parks Commission consists of seven members: Ken Books (Chair), Jenny Schutte (Vice Chair), Jan Dole (Secretary/Treasurer), Becky McInnis (Deputy Secretary/Treasurer), Cesar Arauz, Mark Kohls, and Aaron VanHove. The term for each member is 7 years, from July to June. Appointment to the commission is by the Town Chair, with board approval. The terms are staggered each year, with one member's term expiring each year. If you are interested in an appointment to the Parks Commission, please contact any Town Supervisor, Chair, or Clerk to add your name to the list. Seven years is a long commitment. Some members may not be able to stay that long, which means appointments may be more often than once per year. Meetings are once per month, on the fourth Tuesday held at 7:00 pm.

The Fire Commission consists of three members: Vacant (Chair), Taylor Quinnell, and Jessi Jones. The terms are for 3 years and staggered each year, with one member's term expiring each year. Appointment to the commission is by the Town Chair, with board approval. The Fire Commission meets quarterly, with additional meetings when necessary. The main purposes of the Fire Commission are to review procedures of Wheaton Fire & Rescue, conduct disciplinary hearings for Fire personnel, and ensure the Department is serving the citizens and visitors of Wheaton Township as effectively as possible. If you are interested in an appointment to the Fire Commission, please contact any Town Supervisor, Chair, or Clerk to add your name to the list.

Commissions and committees are just one part of town government then there are all the parts of town government functions and issue resolution. To help residents and businesses with government functions and issue resolution the town board put together the below areas of focus listing that shows both primary and backup contacts for each area. 
#### **ROADS**

With 83 miles of township roads, which is more roads to maintain than most rural townships in the state, and being 100% paved there are certainly challenges. Road replacement costs for 1 mile are \$200,000+ and we need to get 40-80 years out of existing roads based on current funding levels. We continue to pursue ways of prolonging road lifecycles along with pavement and ditch maintenance to maximize the number of improvements to the roads for the available funds. Part of the long term solution will be continued road chip seal and crack patching cycles in order to extend road lifecycles. Plus there are several other ideas being discussed and tested before just turning to a tax levy increase. Road work for 2024 has been bid, approved, and even some is already completed. ## **NEW ATV/UTV ORDINANCE**

We are pleased to announce the Wheaton Town Board approved at their March 19, 2024 meeting <u>opening all</u> <u>Town of Wheaton roads to ATV/UTV traffic</u>. Also, the Chippewa County Board approved at the March 12, 2024 meeting opening all County highways as 16 ATV/UTV routes except for high traffic highways which the Town of Wheaton has some County highways that fit high traffic criteria. The map below shows opened

Chippewa County highways in the Town of Wheaton highlighted in gray (due to non-color printed newsletter). When this initiative started the goal was to provide Town of Wheaton residents with access to ATV/UTV routes where possible while also having an ordinance that promotes safety for all users on the roads. These decisions were not taken lightly and contained ordinance research, review of routes in other surrounding townships, traffic study, along with extensive discussion and collaboration with Wheaton Plan Commission, Wheaton Town Board, Chippewa County Highway Committee, and Chippewa County Board levels to put all of this together.

The newly adopted ordinance Chapter 45 Designation of ATV/UTV Routes and Regulation of ATV/UTV Operation has been placed on the Town of Wheaton website under Government Ordinances and Resolutions.

Please take a few minutes to review the new ordinance in full detail and here are some key highlights:

- Daylight operation only. One half hour before sunrise to one half hour after sunset.
- All operators MUST have a valid Wisconsin driver's license.
- The maximum speed limit is 45 mph unless the posted speed on the road is lower.
- All ATV/UTV must have liability insurance.
- Open intoxicants or controlled substances are NOT allowed while operating on Town of Wheaton roads.
- All ATV/UTV operations are limited to the paved portion of the road only. ATV/UTV should be in a single file.

We understand this ordinance is more restrictive than other ordinances out there; however, the Town of Wheaton also has very different traffic patterns plus ordinances can always be amended in the future. We strongly recommend all ATV/UTV operators on Town of Wheaton roads review Town of Wheaton Chapter 45 ordinance in full detail and that all ATV/UTV operators using Chippewa County highways in the Town of

Wheaton also review Chippewa County ordinance Chapter 58 in full detail. We have included a link to Chippewa County ordinance Chapter 58 on the Town of Wheaton website under the Government Ordinances and Resolutions page.

The overwhelming success of this ordinance and ATV/UTVs on Town of Wheaton roads and Chippewa County highways will come down to responsible operation and voluntary compliance with regulations. After a long time in the making, we certainly would appreciate everyone doing their part to ensure this is a successful positive change for the Town of Wheaton.

Final steps are installing all the necessary signage to comply with all applicable ATV/UTV laws on roads. Signage on Town of Wheaton roads is being sponsored by individual donations and the Chippewa Valley ATVers Club. There is no signage cost to the taxpayers. Once all signage is installed, we will provide another update informing ATV/UTV users the approved roads are now open for ATV/UTV traffic.

#### FIRE DEPARTMENT

We presently have 30 volunteers on the roster. We would like to have closer to 40 volunteers actively participating in this rewarding activity. Most calls are for things other than structure fires. Off road rescues, car crashes, snowmobile incidents, downed power lines, searches, water incidents, and brush fires are just a few of the things dealt with. Medical first responding is the largest part of the fire department responses, with transport ambulances and paramedics coming from Eau Claire or Chippewa Falls. Call the fire station or contact any member of the fire department for more information. Training is provided!

The department is a paid-per-call, all-volunteer department. The fire station is at 3900 38<sup>th</sup> St, Elk Mound and is within the Wheaton Park. It is not a manned station. If you have an emergency, **dial 911 to contact the County Dispatch center**. They page out the firefighters as needed. For non-emergency calls, only, you can dial 715-874-6597 and leave a message. **A return call or action will be made as soon as possible.** You may also send a message to the department through Facebook.

#### **BURNING PERMITS**

Burning permits are not required in Wheaton, but you can only burn what is allowed by state law. Visit the Wisconsin DNR website at <a href="https://dnr.wi.gov/topic/openburning/">https://dnr.wi.gov/topic/openburning/</a> for burning regulations and several fine articles about the alternatives to burning.

- 1. and click on Chippewa County.
- 2. Drive past Wheaton Park / Wheaton Fire & Rescue frontage road sign along Wisconsin 29 South Frontage Road. This is checked and maintained daily.
- 3. Follow Wheaton Fire & Rescue on Facebook.

If you burn, please be careful. You can be responsible for all costs associated with a fire that you started if it has gotten out of control. Burn only when sufficient moisture exists (rain and/or snow cover) in the area, winds are light (under about 7 mph maximum gusts), and temperatures are cool.



#### **CLEAN GROUNDWATER**

Groundwater provides drinking water entirely or in part for as much as 50% of the global population and accounts for 43% of all water used for irrigation. The Town of Wheaton continues to work in support of clean drinking water for all residents. It is important to note that the threat to clean water is lawn fertilizers, septic systems, and agriculture fertilizers and waste. Septic systems are not designed to filter out nitrates. They are designed to break down bacteria.

The Town of Wheaton has sponsored a Well Sampling Project since 2019. This has been offered to residents every year except 2020 during the pandemic. Results from the four years of testing provide baseline information that will help in the following ways:

- Assists the Township, Chippewa County, and U.W. Stevens Point Central Wisconsin Groundwater Center
  with documenting the current and changing conditions of groundwater in order to provide education,
  public information, applied research, and technical assistance in addressing groundwater issues.
- Helps residents monitor their wells for changes in groundwater so actions can be taken if needed.
- Provides information to other Chippewa County government and UW agencies on how soils, well depths, and changes in land use practices affect groundwater.

Continued and expanded residents testing has shown the Town of Wheaton has high nitrate areas. Boiling water will not reduce nitrate levels. In fact, it could make the level of nitrate slightly higher because some of the water will evaporate, however, the nitrate will remain. High levels of nitrates in water can affect everyone such as causing birth defects, blue baby syndrome, thyroid disease, and may increase the chance of colon cancer. High nitrate levels are 10 mg/L and higher.

#### We recommend annual testing of your water, as groundwater can change!

There are multiple ways to address nitrates in groundwater. Some can be quicker and more expensive while others could require more time and be less expensive. There is no one solution that will solve every groundwater issue experienced!

- 1. Reduce nitrate causing uses.
- 2. Septic system inspections.
- 3. Changes in land use practices. There are several winter agricultural cover crop initiatives going on in the Town of Wheaton and Chippewa County.
- 4. Using bottled water.
- 5. Installing reverse osmosis system.
- 6. Installing a new well. We strongly urge residents to reach out to Chippewa County Land Conservation and Forest Management and U.W. Stevens Point Central Wisconsin Groundwater Center for assistance before proceeding forward with this option.

Chippewa County Land Conservation and Forest Management (LCFM) formed an AD HOC Well Program Committee which is led by Lynda Schweikert, Dept. Chair of LCFM. The money comes from the American Rescue Plan Act (ARPA) funds from the Federal Government.

Supervisors Alice Droske and Carolyn Kaiser represent Wheaton on this committee. Other members include representatives from the U.W. Stevens Point (Groundwater Education Specialist), environmental engineers, DNR, Geologists, and Chippewa County Public Health.

<u>Wheaton will have a "Community Well" in the summer of 2024</u>. The Community Well is located in the upper parking lot area at Wheaton Park. People who have high nitrates or wish to use this Community Well may do so at their convenience. Please watch for a notice on the Town of Wheaton website for more information when the well is completed.

Once the Community Well is completed, people will be able to obtain one water jug free of charge from Chippewa County Land Conservation and Forest Management (LCFM). LCFM is located in the Chippewa County Courthouse, 711 N. Bridge St., Chippewa Falls, WI, Room 011, phone number 715-726-7920, email: <a href="mailto:lcd@chippewacountywi.gov">lcd@chippewacountywi.gov</a> The Chippewa County Courthouse hours are Monday - Thursday 7:30 AM - 4:30 PM, Friday 7:30 AM - 11:30 AM

Supervisors Carolyn Kaiser and Alice Droske are planning to do nitrate testing at the Wheaton Town Hall in September 2024.

At the time of this writing, the Town of Wheaton has received maps in regards to water flow, areas of the township where wells have been tested and levels of nitrates in varying areas. There are numerous causes of why your nitrate level may be high. The key point is, we want everyone to be healthy.

Be watchful for visuals as maps will be posted, watch the Town of Wheaton website, come to a town board meeting with questions, and get your water tested.

There are two local companies that will do nitrate testing for free, and there may be others. Gibson Water Care and Culligan's also have technicians that can guide you with options available, if you choose, such as reverse osmosis.

#### DOG LICENSE INFORMATION

Per Wisconsin Statute, all of your dogs over five months of age must be licensed. The annual fee for licensing is as follows:

Spayed or neutered dogs - \$8.00 Unspayed or unneutered dogs - \$13.00 Multiple dogs for up to 12 tags - \$60.00 Each additional tag for multiple dogs in excess of 12 -\$7.00

PROOF OF CURRENT RABIES VACCINATION IS REQUIRED. WITHOUT PROOF OF RABIES VACCINATION, A LICENSE WILL NOT BE ISSUED.

#### **PENALTIES**

You will be charged a minimum late fee of \$25.00 for each dog five months of age or over who is unlicensed by April 1st of each year, or within 30 days of acquiring ownership on or before the dog reaches licensable age. If you fail to have your dog vaccinated against rabies as required by statute, you may be required to forfeit not less than \$50.00 or more than \$100.00.

#### THE WISCONSIN STATE STATUTES REGARDING THE RESPONSIBILITIES OF DOG OWNERSHIP IS AS FOLLOWS:

- (1.) Dogs more than 5 months of age shall be licensed by April 1 of each year or within 30 days of ownership of a dog 5 months of age or older, or a late fee of \$25.00 shall be imposed.
- (2.) Proof of rabies vaccination is required before a license will be issued.
- (3.) Dogs are not allowed to run at large. All dogs must be kept on the owner's premises and under the control of the owner or some other person.
- (4.) Dogs running at large are subject to impoundment.
- (5.) If the owner permits a dog to run at large, the owner shall forfeit not less than \$25.00 or more than \$100.00 for the first offense and not less than \$50.00 nor more than \$200.00 for subsequent offenses.
- (6.) The dog owner can be held liable for a dog causing injury to a person, domestic animal, or property. The penalties imposed can be from \$50.00 to \$500.00, depending on the circumstances. The penalties are in addition to any other liability imposed on the owner of the dog.

If you are a landowner and have tenants who are dog owners, please forward this information to them. Thank you.

#### ITEMS MUST BE STORED AND PLACED IN PROPER DUMPSTERS

- Recyclable glass and plastics go together as does paper and cardboard go together.
- Household trash goes into the compactor. Trash bags for the compactor can be purchased from the attendant.
- Large items & materials go into the large construction dumpsters.
- Metal items go into metal dumpsters.
- Aluminum cans go into the small wire cage.

#### **TOWN PARK**

#### What is the Wheaton Parks Commission?

The Parks Commission aids in development and maintenance of Wheaton Park (63 acres) and boat landing in the township. The Parks Commission term for each member is 7 years, from July to June. Appointment to the commission is by the Town Chair, with board approval. The terms are staggered each year, with one member's term expiring each year. If you are interested in an appointment to the Parks Commission, please contact any Town Supervisor or Chair to add your name to the list. Seven years is a long commitment. Some members may not be able to stay that long, which means appointments may be more often than once per year. We value your input.

The Wheaton Town Park is located at 3900 38th Street, Elk Mound. A second park entrance is located right across the street from 3601 40<sup>th</sup> Street, Elk Mound. Improvements continue to be made as volunteers and funding becomes available.

Wheaton Park was very fortunate again for Earth and Arbor Day this year to have a collaborative project between Elk Mound School District 4<sup>th</sup> Grade classes, Parks Commission, Plan Commission, and Department of

Natural Resources that brought 100 new white pine trees to the 40<sup>th</sup> Street field. Students were able to learn about trees, planting techniques, mulching, and caring for trees after being planted. Thank you to everyone involved with this project and it is great to see trees being planted after the Wheaton Tornado in 2019 took so many from our community. Big thank you to Parks Commission Member Mark Kohls for helping lead the tree planting!

Wheaton Park Little Free Library "Take a Book. Share a Book." has books for all ages! It really is that easy:

- 1. "Take a Book" for reading in the park or other places. Anyone may take a book neighbors, park visitors, even passersby the books are always free!
- 2. "Share a Book" for others in the Little Free Library. Book donations are welcome at this Little Free Library!

In 2023 the Town of Wheaton partnered with Chippewa County and West Central Regional Planning Commission to update the Chippewa County and Town of Wheaton Comprehensive Outdoor Recreation Plans. For the Town of Wheaton, the updated plan included: an inventory of current Town of Wheaton recreational opportunities and infrastructure, an outdoor recreation needs assessment, recommendations, and future action plan.

The outdoor recreation needs assessment focused on 3 areas:

- 1. Space Needs—Whether or not there is adequate land or open space to serve the needs of the population.
- 2. Service Needs—Whether or not outdoor recreational sites are adequately located to serve the needs of the community.
- 3. Activity/Amenity Needs—Whether or not the existing, available park lands allow for a specific, desired recreational activity or amenity.

**PLEASE NOTE:** The future action plan does not guarantee that all listed improvements will be made, but helps identify future priorities for Town-owned facilities as citizen demand and funding is made available through allocation, grants, or partnership opportunities.

The new Chippewa County Comprehensive Outdoor Recreation Plan which includes the Town of Wheaton was finalized in late 2023 and can be viewed at <a href="https://townofwheaton.com/parks-recreation/">https://townofwheaton.com/parks-recreation/</a>.

Check out the new walking trail added to the trail system in 2023. Outfield Pass connects the bottom of the sledding hill/Mounder trail to Oak Knoll field/gravel parking lot. Just look for the trail marker signs with Outfield Pass!


#### INTERESTING RECREATION TIDBITS

The butterfly garden is located on the east side of 38th Street when entering the park and has a wide range of different plant species that are tagged for educational purposes. Plus, there is a picnic table and bench for seating!


