# 2022 Supplemental AIS Watercraft Inspection Hours Funding Process

Dear Hubbard County Lake Associations,

In 2022, the Hubbard County Aquatic Invasive Species (AIS) Program will continue its AIS prevention work through watercraft inspections. The County will be providing State-funded inspection hours on lakes that will closely match the number of State-funded hours provided in recent years. The choice to contribute supplemental funding to the AIS Program, and if so, what amount is entirely your decision. As was the case in 2021, the 2022 contribution deadline will be **January 31, 2022**. This deadline is necessary in order to be able to orchestrate all of the logistical scheduling steps involved with the supplemental funding portion of the AIS Program.

There are very important variables that are dependent on the supplemental funding portion of our Watercraft Inspection Program. The amount of funding that the program receives from Townships and Lake Associations dictates how many watercraft inspectors the staffing agency will need to hire. The supplemental funding that we received the last several seasons allowed us to contract for almost twice as many watercraft inspectors as we could with only a State-funded program. The difference between 25 inspectors and 50 inspectors is very significant in terms of the time requirements for recruiting, training, and equipping watercraft inspectors, developing the year's watercraft inspection schedule, and being ready in time for the open-water season.

Additionally in 2022, as you consider what amount to possibly contribute, please know that the cost of providing supplemental inspection hours will be **\$22.00/hr**. Please be aware that variables beyond the County's control such as the current labor shortage and the potential need to increase wages in order to attract and retain enough inspectors may cause the actual hourly inspector cost to differ from this estimate.

The 2022 watercraft inspection schedule will continue to use standard watercraft inspector daily work shifts:

 Two - 8 hour shifts
 Two - 10 hour shifts

 7:00 a.m. - 3:00 p.m.
 7:00 a.m. - 5:00 p.m.

 11:00 a.m. - 7:00 p.m.
 9:00 a.m. - 7:00 p.m.

Please include a cover letter with your check that provides any related information of note such as whom to contact if we have any questions. Doing so allows us to efficiently and effectively process your contribution.

### **Program Logistics and Guidelines**

The Hubbard County AIS Program must run according to the terms laid out by the Minnesota Department of Natural Resources (DNR) in our Delegation Agreement. This Agreement is what gives the County the legal authority to conduct watercraft inspections. Our inspectors are trained and certified by the DNR and must follow all State laws regarding AIS and watercraft inspections. Although some stakeholders may not always

agree with those specific laws, they must and will be strictly followed. While we definitely appreciate input and feedback, there are certain Agreement requirements that we must follow. When choosing to contribute to the Hubbard County AIS Program, please know that we will follow all State laws and regulations regarding how we conduct inspections and interact with the public.

We ask that you also keep in mind that contributing to the program does not give a stakeholder say in how the Program is carried out. We administer a very large program with many moving parts and individuals involved. Once our inspection schedule is set, it cannot be altered during the season. We deal with programmatic issues such as illness, family emergencies, or severe weather on a weekly, if not daily, basis. We do our best to execute the schedule as planned, but must be able to adjust when issues arise.

Lastly, due to the size of our program and amount of available resources, **please note that contributed funds** are non-refundable.
