

**Town of Osborn Board Meeting**  
**Osborn Town Hall-W3389 Cnty Rd EE**  
**March 11<sup>th</sup>, 2024**

The Osborn Town Board meeting was called to order at 6:32 pm by Chairman, Al Timm. Present was Chairman, Al Timm, Supervisor Dennis Hoffman and Sarah Newling, Treasurer-Kayla Liebergen and Clerk-Darlene Schultz.

Dennis Hoffman made a motion to approve the agenda with the addition of chip sealing. Sarah Newling seconded. Carried.

Sarah Newling made a motion to approve the meeting minutes from February 12<sup>th</sup>, 2024 as printed. Dennis Hoffman seconded. Carried.

An Outagamie County officer was present to hear any concerns the board has. There have been some issues with reckless driving between the Town of Freedom and Town of Osborn. They also mentioned that during road construction the road closed signs are not being obeyed. They asked if the county could do some additional enforcing during this time.

The meeting minutes from the February Fire Department meeting were read.

The board requested that the Plan Commission be notified of the County Town Advisory Task force that is being created for zoning.

No further updates from Cedar Corp. regarding permits for the Edgewood Meadow.

Dennis Hoffman made a motion to accept the quote from Outagamie County Highway department for the repaving French Rd from Mielke Rd to Blohm Rd for approx. \$208,109. Sarah Newling seconded. Carried.

The Plan Commission met with Ryan Quella he is requesting to build storage units on the old Doxbees property. The meeting produced additional questions that need to be investigated. No decision was made.

Need to place bids out for chip sealing of Mielke Rd (French rd. to C), French Rd (Culbertston to Hwy 54) and Vine Rd (Sievert Rd to J).

Dennis Hoffman made a motion to purchase a tv and have it installed from Corporate Network Solution for the board room not to exceed \$1,200. Sarah Newling seconded. Carried.

Open Book will be Tuesday, May 14<sup>th</sup> from 4:30-6:30 pm and Board of Review will be May 29<sup>th</sup> from 5:00-7:00 pm.

Sarah Newling made a motion to approve the Financial Report from Treasurer, Kayla Liebergen. Dennis Hoffman seconded. Carried.

The quote from Bobcat for a new tractor to replace the Kubota was discussed. No action taken.

Dennis Hoffman made a motion to approve the 3-pay checks and check #'s 9893-9917 for a total of \$536,254.07. Sarah Newling seconded. Carried.

Dennis Hoffman made a motion at 9:45 pm to adjourn. Sarah Newling seconded. Carried.
