### **Green County**

## Pop-up Vaccine Clinics & Info Sessions at Twining Park

Throughout the months of June and July a collaborative community health team will be offering 4 pop-up COVID-19 vaccine information and clinic sessions at the Badger State Trail Park Shelter in Monroe (425 14th Ave) with the goal of providing health education and community health opportunities to Green County residents. The information and clinic sessions will take place in the park shelter across from the Veracruz Mexican Market.

Below are the dates, times, and age groups that are eligible for vaccination at the pop-up clinics:

- Friday, June 11: 4-6pm, age 18+
- Friday, June 18: 4-6pm, age 12+
- Friday, July 9: 4-6pm, age 12+
- Friday, July 30: 4-6pm, age 12+

Individuals will be able to choose which COVID-19 vaccine they receive – Moderna or Johnson & Johnson, or Pfizer on the days indicated people 12 and older can receive the vaccine. The Pfizer vaccine is approved for people 12 years of age and older and requires a second dose 3 weeks after the first dose. The Johnson & Johnson vaccine is a single-dose vaccine approved for people 18 years of age and older. On the clinic day that is noted for people ages 18 and up, the Moderna or Johnson & Johnson vaccines will be offered.

Individuals do not need to make an appointment, do not need to pre-register or have an ID, proof of residence, or health insurance to participate. The vaccine is completely free. Limited transportation assistance is available by calling the Veracruz Mexican Market at 608-325-4907. Spanish translation will also be available at each of the information and clinic sessions.

Green County Public Health in partnership with Monroe Clinic, Wisconsin Community Health Fund, Veracruz Mexican Market, UW-Extension Green County and many other community partners have worked together to coordinate these events.

## **Green County Public Health Vaccine Clinics**

Green County Public Health will be offering COVID-19 vaccines on Mondays, Wednesdays and Fridays from 8am to 4pm throughout the month of June. No appointment needed. The walk-in clinics will take place at Green County Public Health which is located in the Green County Government Services Building (N3152 WI-81, Monroe) on the main level. Individuals should enter the building through the "Public Health & Human Services" entrance. Individuals will be able to choose which COVID-19 vaccine they receive – Moderna, or Johnson & Johnson.

Our department is offering on-site COVID-19 vaccination clinics for Green County employers. Public Health Nurses will come to the employer to provide the vaccine for employees and their family members. Employers will have the choice between the Moderna and Johnson & Johnson COVID-19 vaccines. We ask that at least 10 people commit to receiving the

vaccine in order to have an on-site clinic. Neighboring employers are welcome to have a combined clinic to meet the minimum requirement of individuals receiving the vaccine. #### **Monroe Clinic Vaccine Clinics**

Walk-In Wednesdays are being continued in the month of June. These are open to those ages 12+ from 10am to 3pm. Appointments are not required, and individuals will need to register Central Registration upon arriving.

Pfizer COVID-19 vaccine clinics are offered at Monroe Clinic for those ages 12+. Individuals do not need to be a current patient and insurance is not required to receive the vaccine at Monroe Clinic.

There are two ways to schedule:

- Monroe Clinic patients should use their <u>MyChart</u> account to schedule an appointment. If a patient does not have a MyChart account, they can sign up <u>here</u> and then schedule their appointment.
- For those who do not have online access or who are **not a Monroe Clinic patient**, should call Monroe Clinic at 608-324-1815. This line is available Monday through Friday from 8am to 4:30pm.

Pfizer COVID-19 vaccine is currently authorized for individuals aged 12-17. A parent or guardian of this age group should call to schedule the appointment or accompany them at their vaccination appointments.
