

<b>Building Permit Fee (residential new home, includes one driveway permit)</b>	\$250
<b>Fire Number Fee</b>	\$100
<b>Driveway Permit Fee other than for a new house</b>	\$50
<b>Zoning Change Fee (Rezoning Hearing Fee)</b>	\$400
<b>Site Plan Review Fee</b>	\$250
<b>Development Agreement Fee</b>	\$400

<b>Quarry and Mine Conditional Use Permit Fee</b>	\$400
<b>Quarry and Mine Permit Annual Review Fee</b>	\$300
<b>Junk Yard / Salvage Yard Conditional Use Permit Fee</b>	\$400
<b>Junk Yard / Salvage Yard Permit Annual Review Fee</b>	\$300
<b>Livestock Facility Siting and Licensing Fee</b>	\$1000
<b>Sign Fee for signs over 100 square feet</b>	\$1/square foot/side
<b>Short Term Rental New Establishment/Change in Ownership Fee</b>	\$200
<b>Short Term Rental Annual Renewal Fee</b>	\$100
<b>Telecommunication Tower Conditional Use Permit Application Fee</b>	\$3,000
<b>Telecommunications Class 1 Co-Location on an Existing Tower Fee</b>	\$3,000
<b>Telecommunications Class 2 Co-Location on an Existing Tower Fee</b>	\$500




